Re: Notice of Intent to File Citizen Suit Against Administrator McCarthy for Failure to Grant or Deny a Petition to Object to Proposed Title V Operating Permit No. 2305-AOP-R0 issued to Big River Steel, LLC, as Required Under 42 U.S.C. § 7661d(b)(2)

Dear Administrator McCarthy:

Pursuant to the Clean Air Act § 304(b), 42 U.S.C. § 7604(b), this correspondence provides notice that Nucor Steel-Arkansas, a division of Nucor Corporation ("NSA") and Nucor-Yamato Steel Company ("NYS") (collectively referred to herein as "Nucor") intend to file a citizen suit against Administrator McCarthy and the Environmental Protection Agency (collectively referred to herein as "EPA") under the Clean Air Act § 304(a)(2), 42 U.S.C. § 7604(a)(2) for failure to grant or deny the petition ("Petition") which was submitted by Nucor on October 9, 2013.

Nucor filed the Petition under 42 U.S.C. § 7661d(b)(2), which allows any person to petition the EPA to object to an air permit issued pursuant to Title V of the Clean Air Act, if the EPA has not already objected to the permit within its 45-day period to review such permits. The Petition called on the EPA to object to the Title V Operating Permit (No. 2305-AOP-R0) that the

Arkansas Department of Environmental Quality ("ADEQ") issued on June 25, 2013, to Big River Steel, LLC, for the construction and operation of a steel mill located in Osceola, Arkansas.

Nucor hand delivered the Petition to the EPA on October 10, 2013 because delivery via certified mail was not possible due to the federal government shutdown. The EPA had until December 10, 2013 to respond to the Petition. The EPA's failure to grant or deny the Petition within the 60-day period provided by 42 U.S.C. § 7661d(b)(2), constitutes a failure to perform a non-discretionary act. Such a failure is actionable under the Clean Air Act, § 304(a)(2), 42 U.S.C. § 7604(a)(2) which provides that "any person may commence a civil action on his own behalf...(2) against the Administrator where there is alleged a failure of the Administrator to perform any act or duty under this chapter which is not discretionary."

Nucor intends to file suit in either the U.S. District Court for the Eastern District of Arkansas or the U.S. District Court for the District of Columbia following the expiration of 60 days from the postmark date of this notice letter to enforce the EPA's duty to respond to the Petition under 40 C.F.R. § 54.2(d).
