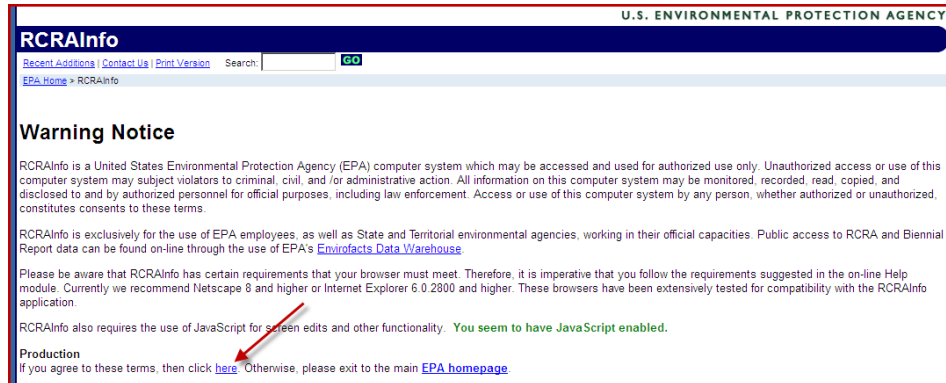


Formal Enforcement Actions

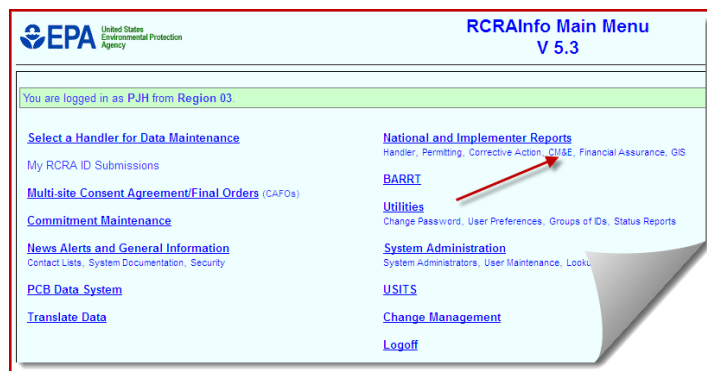
1. Enter RCRAInfo Database <https://www.rcrainfo.epa.gov/>



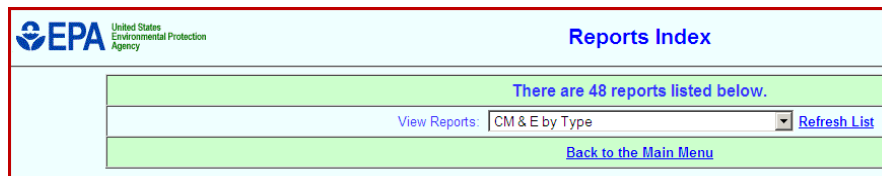
2. Type in your 3-digit "User ID" and "Password"



3. RCRAInfo "Main Menu". Under "National and Implementer Reports", click on "CM&E" (Compliance, Monitoring and Enforcement)"



4. The CM&E "Reports Index" has 48 reports and is divided into "Enforcement", "Evaluation" and "Violation"



5. In the "Enforcement" section, click on "Region 6's Formal Enforcement Actions Report"



6. **Formal Enforcement Actions Report. Log in using your RCRAInfo “User ID” and “Password”. Make your selections. Click “Submit”**
