



**UNITED STATES ENVIRONMENTAL PROTECTION AGENCY
ANNOUNCES AN EXTENSION OF THE PUBLIC COMMENT PERIOD ON
THE PROPOSED PLAN FOR THE
FULTON AVENUE SUPERFUND SITE
GARDEN CITY PARK, NASSAU COUNTY, NEW YORK**

The U.S. Environmental Protection Agency (EPA) announces an extension of the 30-day comment period on the Proposed Plan to address contamination at the Fulton Avenue site in Garden City Park, New York. EPA conducted a public meeting at the Garden City Village Hall on March 6, 2007 to present the Proposed Plan and solicit comments on the plan. In order to present the public with an opportunity to participate in the selection of an interim remedy plan, EPA announced a 30-day public comment period beginning on February 23, 2007 and ending on March 24, 2007. **The comment period has been extended until Saturday, March 31, 2007.** If you would like a copy of the Proposed Plan, contact Ms. Cecilia Echols, Community Involvement Coordinator at 212-637-3678 or 1-800-346-5009 or email: echols.cecilia@epa.gov.

EPA's preferred remedy calls for the installation of systems to remove contaminants from the groundwater, the injection of a chemical (referred to as an "oxidant") to treat potential residual contamination in groundwater, and extensive monitoring of groundwater.

The Remedial Investigation Report, Feasibility Study Report, Risk Assessment, Proposed Plan and other site-related documents are available for public review at the information repositories established for the site at the following locations:

It is important to note that although EPA has identified a preferred remedy for the site, no final decision will be made until EPA has considered all public comments received during the public comment period.
