BioSpyder's project will focus on the adaptive stress response pathways (oxidative stress, unfolded protein response, DNA-damage response, heat-shock response and hypoxia), which play a key role in the adverse effects of diverse environmental perturbagens. HepaRG cells will be treated with at least 4 reference chemicals (and DMSO controls) including: brefeldin A (unfolded protein response), hydroquinone (oxidative stress), benzo(a)pyrene (DNA damage), quercetin (hypoxia) at multiple concentrations. Cells will be treated for different exposure durations to capture the transient nature of, and cross-talk between, different stress response pathways, as well as identify the earliest cellular responses that could only be determined when measuring at a single-cell resolution.

5. In all oral presentations or written publications concerning the Research Project, RECIPIENT will acknowledge PROVIDER's contribution of this Research Material unless requested otherwise. RECIPIENT agrees to protect the information claimed as confidential business information from unauthorized disclosure to the extent permitted by law and consistent with EPA's regulations under 40 C.F.R. Part 2, Subpart B. The foregoing shall not apply to information that is or becomes publicly available or which is disclosed to RECIPIENT without a confidentiality obligation. 
