RE: Submittal of State Government UST Compliance Report

The State of Maryland is pleased to present this report as required by the federal Energy Policy Act of 2005. This report was produced from information available to the Maryland Department of the Environment through the MDE's Oil Control Program. The report was prepared without additional funding from the USEPA.

Maryland has a total of 1,190 active government-owned underground storage tanks (USTs) within our state. These USTs can be found at over 460 facilities. Local Government owns 594 active USTs, the State of Maryland owns 363, and the Federal Government owns 233. Since enactment of the UST regulations, MDE has seen over 3,160 government-owned USTs closed. The closing of USTs and better management of active fuel systems at government facilities have reduced the threat of releases and proven to be protective of public health and the environment.

The Energy Policy Act of 2005 requires a report on non-compliant government UST systems. The Department estimates that the number of non-compliant USTs at 1.7% (see enclosure). The USEPA Region III will pursue and ensure compliance at the listed federal facility and the Baltimore County facilities they inspected. The MDE will continue actions to bring the other two local Government facilities into compliance.
