Enclosed please find the North Dakota Compliance Report for underground storage tanks. The report lists the information you requested, as per your grant guidelines, for noncompliant federal, state and local government underground storage tanks.

As background, North Dakota has record of 237 government underground storage tank facilities with a combined total of 339 tanks. The items of noncompliance listed in the enclosed spreadsheet were, in all cases, associated with corrosion protection, and were the result of not having documentation of testing available. The owners and/or operators have been notified and the state intends to perform followup on-site inspections before the end of September 2007.
