## Background

The Presidential Memorandum accompanying Executive Order 12898, Federal Actions to Address Environmental Justice in Minority Populations and Low-Income Populations, underscores the importance of procedures under NEPA to “focus Federal attention on the environmental and human health conditions in minority communities and low-income communities with the goal of achieving environmental justice.” Further, the Presidential Memorandum underscores public participation opportunities under NEPA, stating: “Each Federal agency shall provide opportunities for community input in the NEPA process, including identifying potential effects and mitigation measures in consultation with affected communities and improving the accessibility of meetings, crucial documents, and notices.”

Recognizing that NEPA provides an important opportunity to advance the consideration of environmental justice through meaningful engagement of minority, low-income, and tribal populations potentially impacted by Federal actions and thereby improve consideration of alternatives and mitigation measures, the Interagency Working Group on Environmental Justice (IWG) formed the NEPA Committee. The Committee’s purpose is to improve the efficiency of the NEPA process across the Federal government to enhance the consideration of environmental justice through the sharing of best practices and lessons learned. Thus, the NEPA Committee supports Federal agency NEPA implementation precisely to “focus Federal attention on the environmental and human health conditions in minority communities and low-income communities with the goal of achieving environmental justice.”

To help achieve this purpose, the NEPA Committee created the NEPA-EJ Resources Compendium. This document gathers into one place the publically available NEPA- and EJ-related documents from Federal agencies (e.g., regulations, guidance, and circulars), providing hyperlinks to each document for quick access. Each of the links, by agency, provides documents relating to regulations, orders/directives, guidance, EJ Strategic Plans, and other relevant materials. The scope of the collection of materials is based on those federal agencies that are subject to NEPA. These resources are thus designed to support those who prepare, review and comment on NEPA review documents.
