**CONSENT FOR ACCESS TO PROPERTY**

Name: (b) (6) individually, and as owner and representative of San Juan Corp. and Salem Minerals.

Location of Properties: (b) (6) San Juan Corp./Salem Minerals' lands on or near the Gladstone area, including the Harrison Mill Site, Anglo Saxon Lode, the claims near and including the Upper Gold King 7 Level mine and the Success Placer, Sampson MS, and claims near and including the Mogul and Grand Mogul mines and other claims identified in the attached list (the Properties).

I consent to continued access through December 2015 for officers, employees, and authorized representatives of the United States Environmental Protection Agency (EPA), Bureau of Land Management/US Department of Agriculture (BLM/USDA-FS, and State of Colorado, and their designees (contractors), for the purposes below:

1. Conducting field inspections and investigations, and staging equipment, constructing of temporary mine water management units (e.g. settling ponds) to evaluate the mine waste, adit discharges and related seepage, and the associated impacted lands.
2. The drilling of holes and installing monitoring wells and other actions related to the investigation of surface or subsurface contamination in/on the waste dumps and adjacent lands.
3. Sampling and monitoring water, soil, and mine waste material from waste rock dumps, tailings impoundments, and mine workings or other areas as necessary to evaluate releases of hazardous substances.
4. Constructing a new adit portal and opening the collapsed portion of the Upper Gold King Mine (7-Level) tunnel. (In support of this work, San Juan Corporation is offering to provide Steel arch sets, I-beams, HDPE pipe and cement mix needed for the portal and ground support.)

I realize that these actions are undertaken pursuant to EPA's response and enforcement responsibilities under the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (Superfund), as amended, 42 U.S.C. §§ 9601 et seq.
