Progress

- Phase I Video is completed
- Phase II plantings are underway
- Phase II Visioning Plan is underway NPS is lead
- Connections with other agencies/local groups underway
- NPS/NOAA Marine Debris plan opportunity, also NFWS "Pack it In, Pack it Out" signage?)
- Good community connections

Challenges

- Staffing resources (UNO factor)
- Accessibility of site to NO general population and tourists
- Lack of awareness about the site (Visioning Plan to address)
- Need for additional grants

East End/Bayou Sauvage Pier and Area

Progress

• MOU created

Challenges

- Access to leadership decision makers
- Funding could be at risk (MOU ends and needs to be renewed by Summer 2016)

Ponchartrain Beach and Pier

Progress

• Close to opening beach (Levee Board sign-off in May)

Challenges – Ponchartrain Beach

- Who is going to run the beach?
- Possible liability issues who is liable

- Does beach need lifeguards?
- Restrooms?

Ponchartrain Beach

Progress

- Partnership between Levee District and LPBF
- Restoration is about ½ done

Challenges – Ponchartrain Beach

- Who is going to run the beach?
- Possible liability issues who is liable

New Canal Lighthouse & West End Pier

Progress

- Lighthouse restoration is completed.
- More than 1,000 tours a month
- Additional educational features added.
- Linkages to environmental education

Challenges

- Deck area needed
- Nearby old dock needs to come down

Lafitte Corridor

Progress

- Going well 92% completed, will open this summer. Tree plantings nearly done and 2.6 miles of trail completed.
- Addressing drainage problems
- Public is excited and engaged
- Bikeway signage underway
- Recycling bins will be added

Challenges

- Need long-term management plan
- Funding for additional capital improvement projects

Overall Challenges/Needs for UWFP

- New Orleans is not there regarding the UW objectives. Stakeholders are still afraid of public access to water.
- Dearth of leadership. Difficult to access management and get them to step up. No bold, assertive leadership for the initiative.
- Some stakeholders are territorial and guard their power
- Communications issues leadership needs to communicate with each other
- Need more community outreach
- Need asset mapping looking at strength and weaknesses, needs resources
- Need to leverage connections
- Need simple, cohesive messages
- Need integrated systems

Themes Linkages: Where do we go from here?

- Connectivity of recreational spaces, e.g. Mississippi River to LP
- Integrated Greenway/Historical Areas/District
- Water Quality
- Accessibility
- One Big System
- Economic aspects both social and resource development sustainability/tourism
- Community Outreach
- Broaden the industrial outreach Economic and Community outreach Private Public Partnership and possible linkages
- Grassroots initiatives
- Need understanding the system, ownership of water and how it integrates in daily lives
- Coastal issues understanding what is inside and outside crossing the boundaries
- Environmental Education

Urban Waters Partnership Benefits

- Natural, social, economic capital all flow into this
- Resiliency New Orleans leads the way internally and nationally in water issues and management. (Discussion of the larger \$15 billion water infrastructure in play in N.O. – inside/outside the levee ring connection)
- Education about water and all its usages
- Knowledge of living water systems
- Partnership will help create common language/messages
- Can help determine what works for New Orleans (not generic)
- Lends legitimacy to water projects/efforts
- Mechanism to vet ideas, projects, concepts
- Opportunity for even more sharing among stakeholders
- Authority brings this into play across all projects/initiatives

- Opportunity to collaborate. (Power of convening in real time with other stakeholders)
- Transfer of information
- Demystifies the whole federal/local process
- Opportunity for more public/private partnerships
- Structure to planning process
- Strength in numbers unity. More staff capacity when shared over multiple stakeholder entity

Importance/role of Federal Partners

- Assist in transferring information among stakeholders (e.g. Living learning labs)
- Promotes collaboration that doesn't always happen
- Source of information
- Funding support
- Sets a good example for state/local governments

 - Federal Reserve
 - Federal Partner agency programs
 - Commercial partners
 - Trade organizations
 - State CPRA
