## **EPA Finalizes Rule to Modernize Clean Water Act Reporting**

The U.S. Environmental Protection Agency (EPA) finalized a rule to modernize Clean Water Act reporting for municipalities, industries, and other facilities. The final rule will require regulated entities and state and federal regulators to use existing, available information technology to electronically report data required by the National Pollutant Discharge Elimination System (NPDES) program instead of filing written paper reports.

EPA estimates that once the rule is fully implemented, the 46 states and the Virgin Islands Territory that are authorized to administer the NPDES program will collectively save approximately \$22.6 million each year as a result of switching from paper to electronic reporting. The final rule will make facility-specific information, such as inspection and enforcement history, pollutant monitoring results, and other data required by NPDES permits accessible to the public through EPA's website.

"Electronic reporting will give the public full transparency into water pollution sources, save millions of dollars, and lead to better water quality in American communities," said Cynthia Giles, Assistant Administrator for EPA's Office of Enforcement and Compliance Assurance. "This rule will significantly reduce the burden and costs of paperwork, freeing up limited resources for states and other regulatory authorities to focus on the most serious water quality problems. # The Department of Commerce and the Treasury Department Coordinated New Actions in Support of the Cuba Policy

On September 21, 2015, the Commerce and Treasury Departments took additional coordinated actions in support of the President's Cuba policy. These actions included a rule published by the Commerce Department's Bureau of Industry and Security (BIS) that amended the terms of existing license exceptions that are available for Cuba, increased the number of license exception provisions that are available for Cuba, created a new Cuba licensing policy to help ensure the safety of civil aviation and the safe operation of commercial passenger aircraft, and made the deemed export and deemed reexport license requirements for Cuba consistent with other sanctioned destinations. 

### Franklin Paint Company in Massachusetts Reduces its Use of Toxics

Franklin Paint Company, an employer of 28 people in Franklin, Massachusetts, produces about two million gallons of traffic and field marking paint annually. Over the past two decades, the company has reformulated their products and eliminated the use of xylene and methanol, and dramatically reduced the use of lead compounds, chromium compounds, and toluene, resulting in an annual decrease of 900,000 pounds of reportable toxics use. The adoption of safer substitutes to these hazardous chemicals has made it possible for the company to promote its products as a greener alternative when compared to its competitors, receiving positive responses from customers. Throughout the reformulation process, Franklin Paint Company has worked with the Massachusetts Office of Technical Assistance (OTA) to find safer formulations, develop emergency contingency plans, and improve worker health and safety. **AGENCY:** Environmental Protection Agency

**ACTION:** Proposed Rule

**SUMMARY:** This action proposes technical and editorial corrections and revisions to regulations related to source testing of emissions. This proposed rule will make corrections and updates to testing provisions that contain inaccuracies and outdated procedures, and provide alternatives to existing testing regulations. These revisions will improve the quality of data and provide testers flexibility to use recently-approved alternative procedures. Many of these changes were suggested by testers and other end-users, and they will not impose new substantive requirements on source owners or operators.

SUMMARY: The Comprehensive Environmental Response, Compensation, and Liability Act of 1980 ("CERCLA" or "the Act"), as amended, requires that the National Oil and Hazardous Substances Pollution Contingency Plan ("NCP") include a list of national priorities among the known releases or threatened releases of hazardous substances, pollutants or contaminants throughout the United States. The National Priorities List ("NPL") constitutes this list. The NPL is intended primarily to guide the Environmental Protection Agency ("the EPA" or "the Agency") in determining which sites warrant further investigation.

Dry cleaners learned how to convert their operations, reduce energy costs and improve sustainability at the 2015 Colorado Dry Cleaning Alternatives Trade Fair in Denver on June 14.

Experts presented on a variety of topics from efficient solvent use to boiler maintenance. Walter Avramenko of the Colorado Department of Public Health and Environment educated attendees about the hazards of perchloroethylene and discussed how plant and property owners share the significant financial burden for contamination. The presentations were followed by roundtable sessions, and more than 40 vendors were on hand to display alternative solvent machines and other advanced equipment.

The free, one-day-day event was hosted by the department's <u>Small Business Assistance Program</u> and environmental divisions of the <u>Rocky Mountain Fabricare Association</u>.

"We want to encourage people to switch to more environmentally friendly alternatives," Avramenko said. "Having these experts in one place can help the small business owner move toward optimal solutions."
