Dear Mr. Coleman;

In a letter dated May 26, 2011, Louisiana recommended two parishes be designated as nonattainment based on a review of sulfur dioxide monitoring data for the period 2008-2010. Since that writing, the monitoring data for West Baton Rouge Parish has continued to improve. The current design value for this monitor is 57 parts per billion (ppb) which is below the new, more stringent level of 75ppb. There has not been an exceedance of the 1-hr standard since October 6, 2010. Based upon this data, this monitor is expected to reach attainment at the end of the 2012 monitoring year.

Therefore I am requesting that the EPA postpone its designation of West Baton Rouge Parish as nonattainment for the 2010 Sulfur Dioxide NAAQS as recommended. All other recommendations remain intact per the May 26, 2011 letter.

Recommendations for Area Designations 2010 Sulfur Dioxide National Ambient Air Quality Standards (NAAQS)

Dear Dr. Armendariz:

In accordance with Section 1107(d) of the Clean Air Act Amendments of 1990, the state of Louisiana is pleased to propose recommendations for area designations for the Sulfur Dioxide NAAQS. Attachment A provides a full listing of all parish recommendations is listed by Air Ouality Control Region (AQCR).

Based on a review of the sulfur dioxide monitoring data for the period 2008-2010, Louisiana recommends a designation of nonattainment for the following monitored parishes:

- West Baton Rouge Parish
- St. Bernard Parish

Louisiana is further recommending 20 parishes to be designated as unclassifiable. These parishes do not have established monitors; however, these parishes have emission sources that may necessitate future modeling based on the newly established standard. (75 FR 35520)

Based on the final rule, Louisiana is recommending 42 parishes as attainment. Of these parishes, four have recommendations based on monitored data. These parishes are Calcasieu, East Baton Rouge, Ouachita and Caddo. The remaining 38 parishes are being recommended as attainment based on the parish-wide sulfur dioxide emissions. Using the 2009 Louisiana emissions inventory, none of these parishes have total emissions greater than 75 tons per year. As outlined in the final rule, EPA suggests that modeling would not be necessary in these areas based on a lack of major sources as well as the lack of any other sources that may be anticipated to cause or contribute to a violation.

In addition, not all areas of Louisiana necessitate monitoring. These 38 parishes do not currently have established monitors. Under US EPA's final rule, additional monitoring may be necessitated in certain areas of the state based on a population weighted emissions index (PWEI)
