Joan B. Rogers has been named the new Deputy Director of EPA's Office of Small Business Programs (OSBP). Joan joined the Agency in 1991 and during her tenure with the Agency, has served in several capacities, all impacting the Agency's policies with respect to rule development. As the Special Assistant to the Associate Administrator for the EPA's Office of Policy, Joan provided substantive guidance on policy and rule development gained through years of experience as a program analyst, conducting analysis of Agency regulations and policies. Joan also served as the Agency's team lead for the Regulatory Flexibility Act as amended by the Small Business Enforcement Fairness Act (RFA)/SBREFA) for five years. In that role, she worked with small entities, small business trade associations, the Office of Management and Budget (OMB), the Small Business Administration (SBA), the General Accounting Office (GAO) and EPA program offices to ensure that small entity impacts and concerns were considered in the development of Agency rulemakings.

In October 2008, Joan joined OSBP as the Agency's Asbestos and Small Business Ombudsman (ASBO), where she serves as the liaison between EPA and the small business community, working with internal and external customers and stakeholders to address small business environmental regulatory impacts and concerns. As the ASBO, the Agency has earned an "A" on the SBA Advocacy Scorecard throughout her tenure in this capacity. As the Deputy Director of OSBP, Joan will continue in her role as the Agency's ASBO and continue to be a strong advocate for small business in all perspectives.

EPA Proposes Additional Details on the Clean Energy Incentive Program

After extensive engagement with community groups and other stakeholders, EPA is proposing additional details for public comment about the optional Clean Energy Incentive Program (CEIP), which was included in the final Clean Power Plan. The CEIP was designed to help states and tribes meet their goals under the plan by encouraging early investments in zero-emitting renewable energy generation, and by removing barriers to investment in energy efficiency in low-income communities. The proposal provides a key opportunity for stakeholders to comment on several program design elements including: clarifications about project eligibility including expanding eligibility to solar energy project in low-income communities, providing states with the flexibility to choose one or more existing definitions of low-income community, and how CEIP incentives should be made available to eligible renewable energy and energy efficiency project providers. 
Virgin Islands Small Business Environmental Assistance Program (SBEAP) Holds its First Small Business Award Ceremony

SUMMARY: The Environmental Protection Agency is amending its hazardous chemical reporting regulations due to the changes in the Occupational Safety and Health Administration (OSHA) Hazard Communication Standard (HCS). OSHA's HCS was recently revised to conform to the United Nations Globally Harmonized System of Classification and Labeling of Chemicals (GHS). Under the revised HCS, chemical manufacturers and importers are required to evaluate their chemicals according to the new criteria adopted from GHS to ensure that they are classified and labeled appropriately.

SUMMARY: This action finalizes amendments to the current new source performance standards (NSPS) and establishes new standards. The new standards for the oil and natural gas source category set standards for both greenhouse gases (GHGs) and volatile organic compounds (VOC). Except for the implementation improvements, and the new standards for GHGs, these requirements do not change the requirements for operations covered by the current standards.

EPA Extends Public Comment Period to Add Indianapolis Site to SuperFund's National Priorities List

In response to requests from members of the public, U.S. Environmental Protection Agency will allow an additional 90 days to comment on its proposal to add the Riverside Groundwater Contamination site in Indianapolis to the Superfund cleanup list. The public comment period now extends until Sept. 5, 2016. Superfund is the federal program that investigates and cleans up the most complex uncontrolled or abandoned hazardous waste sites in the country. EPA proposed adding the site to Superfund's National Priorities List in April 2016. In 2012, a plume of chlorinated solvents was discovered at the site near the Riverside and White River municipal well fields. To date, only low levels of contaminants have been found in some municipal wells. The concentrations of chlorinated solvents detected were well within federal and state drinking water standards

Citizen's Energy Group is treating the drinking water and has been meeting all EPA requirements under the Safe Drinking Water Act. Written comments may be submitted and reviewed online at:
