Air Monitoring Summary

Camp Minden Area I Start Time: 10-13-2016 1800 - End Time: 10-14-2016 1800

October 14, 2016 – EPA monitored for seven ambient air pollutants over a 24 hour period at the Camp Minden Area I air monitoring location. The seven pollutants included carbon monoxide, carbon dioxide, nitrogen oxide, nitrogen oxide, nitrogen oxide, and fine particulates. Over the 24 hour period, each of these pollutants were detected below EPA's National Ambient Air Quality Standards or the action benchmark when an air quality standard had not been previously established.

Below is a summary of Camp Minden Air Monitoring Data collected at the location referenced above. The table contains a detailed listing of the following:

- 1 Average reading of each analyte from October 13, 2016 1800 through October 14, 2016, 2016 1800
- 2 Highest measurement of each analyte from October 13, 2016 1800 through October 14, 2016 1800




** Note: PM2.5 was captured in 60-min averages. All other analytes were captured in 1-min averages. Negative BAM readings continued to be offset by +4.7 for all hours. All monitors were operating normally. The BAM experienced a tape stall from 0300-0600 CDT; was reset during 0700 hour (fault value); unit recovering from restart hours 08-09 CDT. Hours 0300-0900 CDT invalidated. The tape reel was recently replaced, and unit is experiencing occasional tape issues as tape tension normalizes.






Camp Minden Area I Station Location Map for 14 October 2016















Hourly Averages NO2 (ppb) NAAQS 100 ppb
