#### **Air Monitoring Summary**

### Camp Minden Area I Start Time: 12-14-2016 1800 - End Time: 12-15-2016 1800

December 15, 2016 – EPA monitored for seven ambient air pollutants over a 24 hour period at the Camp Minden Area I air monitoring location. The seven pollutants included carbon monoxide, carbon dioxide, nitrogen oxide, nitrogen oxide, sulfur dioxide, and fine particulates. Over the 24 hour period, each of these pollutants were detected below EPA's National Ambient Air Quality Standards or the action benchmark when an air quality standard had not been previously established.

Below is a summary of Camp Minden Air Monitoring Data collected at the location referenced above. The table contains a detailed listing of the following:

- 1 Average reading of each analyte from December 14, 2016 1800 through December 15, 2016, 2016 1800
- 2 Highest measurement of each analyte from December 14, 2016 1800 through December 15, 2016 1800






## **Camp Minden Area I Station Location Map for 15 December 2016**















# Hourly Averages NO2 (ppb) NAAQS 100 ppb
