Air Monitoring Summary

Camp Minden Area I

Start Time: 12-2-2016 1800 - End Time: 12-3-2016 1800

December 3, 2016 – EPA monitored for seven ambient air pollutants over a 24 hour period at the Camp Minden Area I air monitoring location. The seven pollutants included carbon monoxide, carbon dioxide, nitrogen oxide, nitrogen oxides, sulfur dioxide, and fine particulates. Over the 24 hour period, each of these pollutants were detected below EPA's National Ambient Air Quality Standards or the action benchmark when an air quality standard had not been previously established.

Below is a summary of Camp Minden Air Monitoring Data collected at the location referenced above. The table contains a detailed listing of the following:

- 1 Average reading of each analyte from December 2, 2016 1800 through December 3, 2016, 2016 1800
- 2 Highest measurement of each analyte from December 2, 2016 1800 through December 3, 2016 1800




** The monitoring database has been validated for calendar day 12/03/16 (through 00:00 12/04/16 CST). All analyzers were operating normally. The PM2.5 readings were steady and between 25 – 35 ug/m3 entire day. These readings appear distinctly higher than the other on-site monitors, and an unusual pattern for the station. The data were validated, pending BAM condition checkup and any potential conditions on-site that may have affected readings.






Camp Minden Area I Station Location Map for 3 December 2016















Hourly Averages NO2 (ppb) NAAQS 100 ppb
