Where the Corps has made a final permit decision, it is documented below and will not appear in subsequent reports. During this reporting period, EPA received 153 Individual standard CWA permit public notices, performed a detailed review of 80%, and subsequently provided comment letters on 7% of them. EPA is not the only commenter on Corps public notices. Other federal and state agencies and the public routinely provide comments to the Corps. Of the new public notices in Section I, the Corps has issued 5 permits, 0 permits were denied, 5 applications were withdrawn, and 143 are still being processed.
