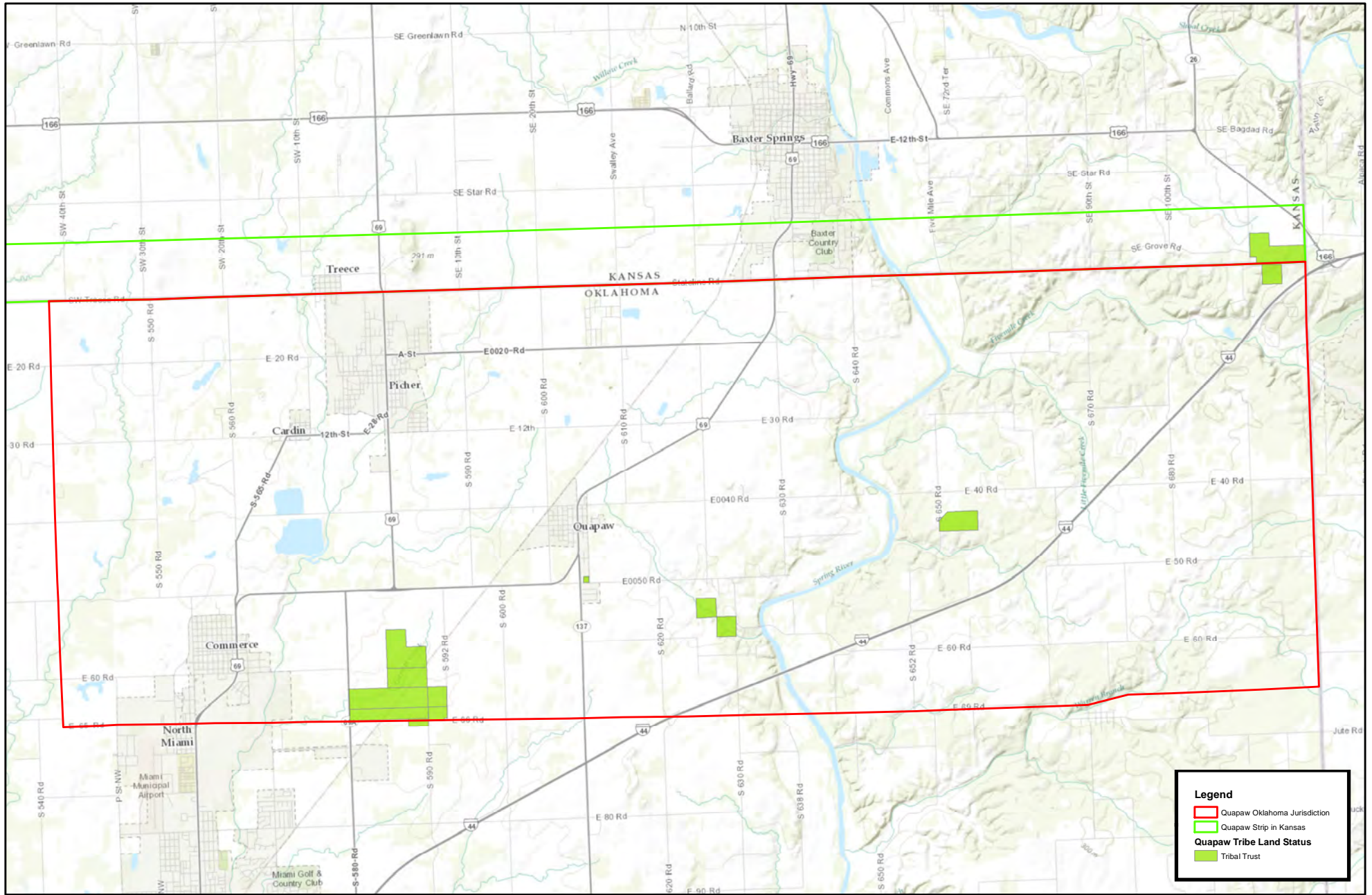

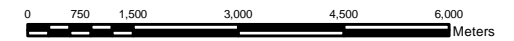
QUAPAW TRIBE OF OKLAHOMA

Quapaw Tribe Trust Property



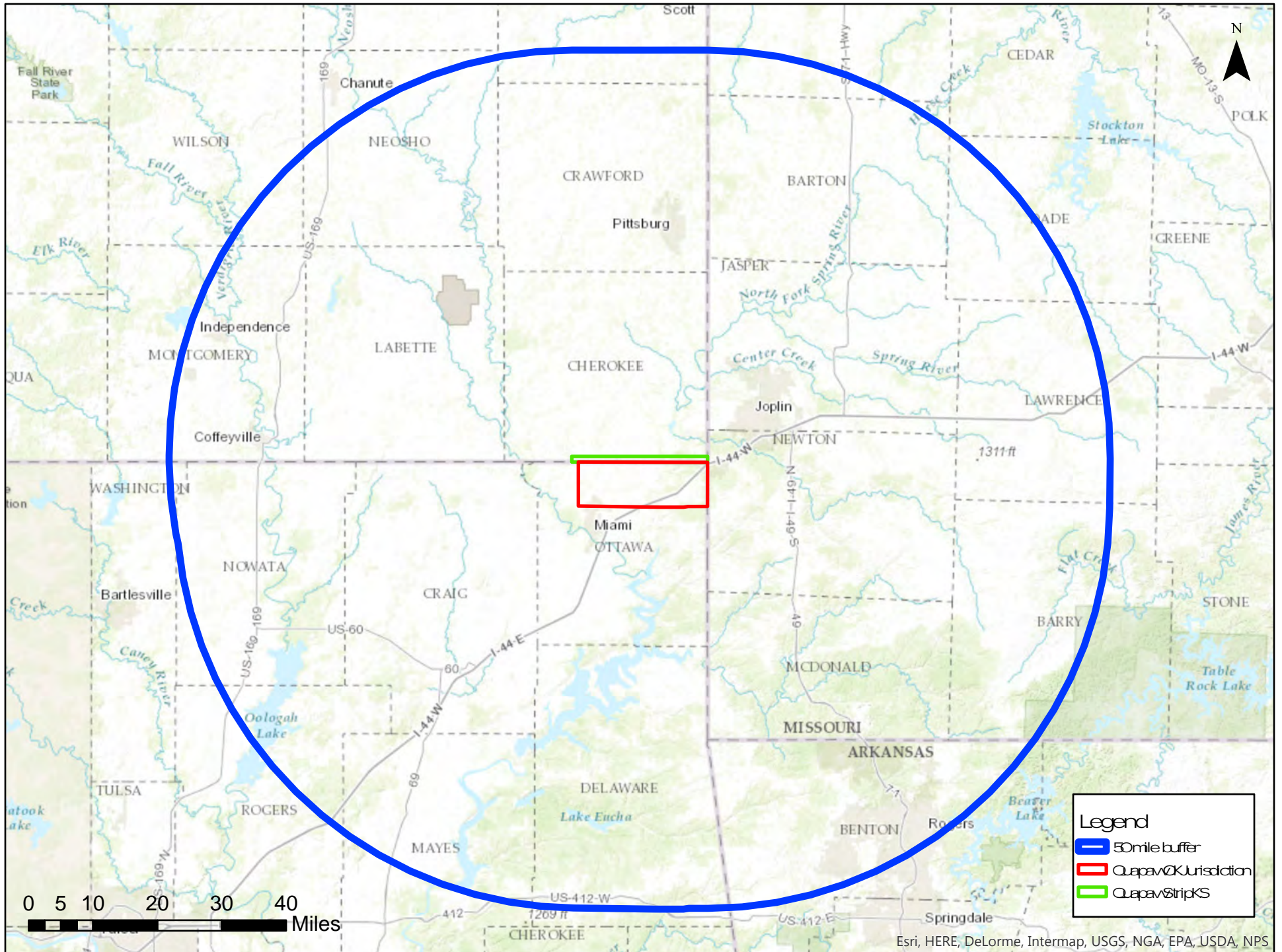
