The following information was obtained verbally from Steve Kroon unless otherwise noted.

Company Ownership: Privately owned company

## **Process Description:**

SHB receives bulk solid materials, mainly via barge, and stores the materials onsite for customers. SHB is very rarely required to manipulate the bulk material, via a crushing and screening process.

SHB has been in settlement discussions with EPA, in response to a July 15, 2014 Notice of Violation, and EPA used the site visit as an opportunity to view the current status of operations and installation of new injunctive relief.

**Staff Interview:** As of the date of the inspection, Steve Kroon informed EPA that he has never performed a Reference Method 9 opacity test onsite. He has only taken qualitative visual observations.

### **TOUR INFORMATION**

EPA toured the facility: Yes

#### **Data Collected and Observations:**

During the tour, EPA saw a recently loaded truck exiting the Ryerson Building. As the truck exited, a large plume of visible fugitive emissions was released from the back of the truck and crossed over the property line at the railroad tracks. Mr. Kroon confirmed that he saw the visible fugitive emissions and believed the emissions to be around 15% opacity. He stated that over a 6 minute average he believed the emissions would be in compliance with the facility's permitted opacity limit so there was no need to take emissions readings or perform any corrective actions.

**Field Measurements:** were not taken during this inspection. Eight pictures were taken during the walking tour.
