

**K.A.R. 28-19-14 PERMITS REQUIRED**

28-19-14. **Permits Required.** The reference in K.A.R. 28-19-19 to a permit condition under this regulation, the reference in K.A.R. 28-19-31 to a permit issued under this regulation, and any other reference in these rules to a permit under this regulation, shall be interpreted to include permits issued under K.A.R. 28-19-300 through 28-19-304 and K.A.R. 29-19-500 through 28-19-578.
