WHAT IS E-MANIFEST?

e-Manifest

EPA's e-Manifest is a national system for electronically tracking hazardous waste shipments. e-Manifest will improve access to higher quality and more timely shipment data and will save valuable time, resources, and dollars for industry and states.

- E-Manifest will provide:
 - Enhanced shipment tracking capabilities for users;
 - Improved access to higher quality and more timely waste shipment data;
 - Significant paperwork reductions and cost savings,
 - Enhanced manifest inspection and enforcement capabilities for regulators;
 - One-stop manifest copy submission to EPA and to all interested states.

TOP 5 THINGS YOU NEED TO KNOW ABOUT E-MANIFEST

e-Manifest

- e-Manifest will launch nationwide on June 30, 2018.
- e-Manifest will be available for testing, prior to launch, through Spring 2018.
- All ***receiving facilities*** that receive waste that must be manifested under federal law or receive state-only hazardous waste that must be manifested as required by either the state in which the waste was generated or received, must submit those manifests to EPA either in paper or electronically. EPA will charge receiving facilities an associated fee for each manifest submission.
- Handlers will be required to register for e-Manifest to submit manifests electronically and to make corrections.
- Once the system launches, e-Manifest data will be available to the public 90 days post-receipt of the manifest.

QUICK UPDATE ON E-MANIFEST

e-Manifest

■ **System Development**

- Release 2 of e-Manifest has been completed on schedule January 2018. Release 2 functionality includes:
 - Ability to save, update, and retrieve a manifest via website and through a system-to-system interface
 - Generators, transporters, and receiving facilities have the ability to sign manifests electronically
 - State user functionality in the web application
 - Available for user testing

■ **Advisory Board**

- Met September 26-28, 2018, on user registration and account activation issues that need resolution prior to the launch of the e-Manifest system.
- On January 4, 2018, the official minutes for this meeting were published in the meeting's public docket at [regulations.gov](https://www.regulations.gov) (Docket no. EPAHQ-OLEM-2017-0368)
- EPA is currently reviewing the Advisory Board's recommendations.

QUICK UPDATE ON E-MANIFEST

e-Manifest

- **User Fee Final Rule**
 - Final rule completed in December 2017 and published on January 3, 2018 (83 FR 420)
 - FAQs available on e-Manifest website
- **Communication/Implementation Activities**
 - Redesigned e-Manifest website (www.epa.gov/e-manifest)
 - Regional/state meetings ongoing; upcoming industry conference in California in February
 - Will have additional monthly webinars and API technical workshops/webinars for industry in coming months
