<sup>1</sup> The Hazardous Waste Generator Improvements Rule (Revision Checklist 237) redesignated the existing 263.12 as 263.12(a) and added 263.12(b) and its subparagraphs to the federal regulations.

<sup>263.20(</sup>a) was added to the federal regulations as part of the Base Program Checklist III. It was subsequently amended by the final rules addressed by Revision Checklists 31 and 152. The final rule addressed by Revision Checklist 207 completely revised the Base Program provision by splitting it into two subparagraphs, 263.20(a)(1) (Manifests) and (a)(2) (exports) and introducing a new subparagraph (a)(3).

- 263.20(a)(2) and (a)(3) are included in the February 7, 2014 final rule (79 FR 7518; Revision Checklist 231); however, there were no changes to the provisions. Note that the provision at 263.20(a)(2) is not delegable. States should retain the reference to "EPA".
- 4 At 263.20(a)(4)(i) and 263.25(a), States must retain the reference to 262.25(a) and cannot replace it with a state provision.
- 5 At 263.20(a)(4)(iv), States should retain the term "EPA" and may change "state" to the name of the state.
- 6 263.20(g) and (g)(1) (g)(3) are included in the November 28, 2016 final rule (81 FR 85696; Revision Checklist 236); however, there were no changes to the provisions.
- 7 263.20(g)(1) and (2) were added to the federal regulations as part of the Base Program Checklist III. The final rule addressed by Revision Checklist 207 moved the signature requirement from (g)(2) to (g)(1) and added clarification at 263.20(g)(1) that the signature and date required can be found in the International Shipments block on the manifest. 263.20(g)(2) only contains the requirement to retain one copy of the manifest.
- 8 263.20(g)(3) and (g)(4) are included in the March 4, 2005 final rule (70 FR 10776; Revision Checklist 207); however, there were no changes to the provisions.
- 9 263.20(g)(4) was added to the federal regulations as part of the final rule addressed by Revision Checklist 31; however, the language was subsequently relocated to 263.20(g)(4)(ii) as part of the final rule address ed by Revision Checklist 236 which also introduced a new 263.20(g)(4) introductory paragraph and (g)(4)(i).
- 10 263.21(a)(1) (a)(4) are included in the January 3, 2018 final rule (83 FR 420; Revision Checklist 239); however, there were no changes to the provisions.
- 11 263.21(b) was added to the federal regulations as part of the Base Program Checklist III. The final rule addressed by Revision Checklist 207 revised (b), renumbering it as subparagraph (b)(1), and created (b)(2) and its subparagraphs. Subsequently, Revision Checklist 239 revised 263.21(b)(1), added a new 263.21(b)(2) through (b)(4) and redesignated the existing 263.21(b)(2) (b)(2)(ii) as 263.21(c) (c)(2) without making any changes to the redesignated provisions.
