USER FEES FOR FY2020/2021

e-Manifest

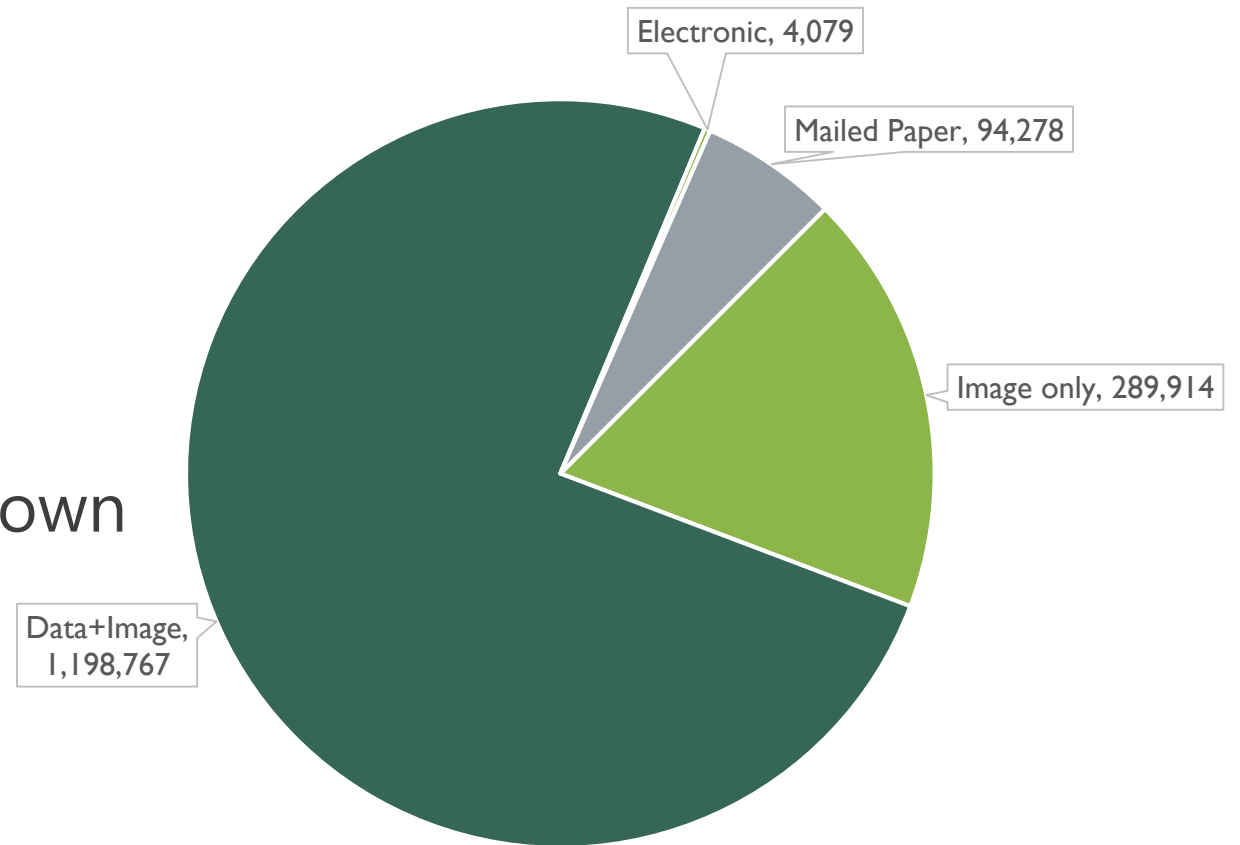
- We have announced upcoming e-Manifest user fees for Fiscal Years 2020 and 2021 (effective October 1, 2019, through September 30, 2021).
- These user fees are set based on the projected manifest usage rates and program costs during this period.
- Any manifest that originates (signed by the generator) on or after October 1, 2019, will be charged the fiscal years 2020 and 2021 user fee rate when submitted to the e-Manifest system by the receiving facility.
- Receiving facilities will see their first invoices reflecting the new rates starting in November 2019.

SYSTEM DEVELOPMENT UPDATES

e-Manifest

- Recently added to Production
 - Added ability for transporters to call GET Manifest service
 - Added rule to prevent ship dates older than 6/30/2018
 - Set maximum of 12 characters for Transporter IDs
 - Improved error messages for non-public sites
 - Enhancements to the invoice page and PDF, as well as adding CSV export of manifests on an invoice
 - Added Generator Name to industry "All manifests" view
- Recently added to Pre-Production for User Testing
 - Updated Transporter Lookup Maintenance to reflect updates after handler source record changes.
 - Inserted the new PHARMS waste code that is only available for use in e-Manifest.
 - Updated unsigned manifest notification to be sent to industry users weekly.
- Functionality under development
 - Inspectors report
 - Broker/Transporter

COMMON MANIFEST ERRORS

e-Manifest

1. Instructions for Completing the Uniform Hazardous Waste Manifest
2. Many manifests that are disheveled, illegible, have multiple lines partially crossed out, missing key information.
 - Receiving Facilities – Please have current phone number
3. Generators and transporters mailing their paper copy of the manifest to EPA
4. Receiving facilities not submitting manifests to the EPA
5. Generators/transporters/receiving facilities not signing or dating their manifests
6. No Management Method Codes for Hazardous Waste
7. Incomplete PCB Information
 - Load type
 - Weight in KGs
 - Earliest date of Removal from Service
8. Sites are not registering their facilities
