Financial Support for Water Reuse from the Clean Water State Revolving Fund Clean Water

As part of EPA's Water Reuse Action Plan (WRAP), the Clean Water State Revolving Fund (CWSRF) has collected information on financial assistance provided to communities throughout the United States to demonstrate the level of support that has been provided for water reuse projects. The WRAP is the culmination of a year-long journey in collaboration with partners across the water sector to help drive a safe, sustainable, and resilient water future. The WRAP includes 28 action leaders, more than 80 partners, and more than 200 implementation milestones across 37 developed actions. This document was completed as part of Action 2.6 that will result in an improved understanding of the finance options that can support water reuse projects. What follows is information through 2019 submitted by the state CWSRF programs into the CWSRF's two primary financial databases.

About the Clean Water State Revolving Fund

The CWSRF was created by the 1987 amendments to the Clean Water Act as a financial assistance program for a wide range of water infrastructure projects. The program is a partnership between EPA and the states, which have the flexibility to fund a range of projects that address their highest priority water quality needs.

Using a combination of federal and state funds, CWSRF programs provide loans to eligible recipients to address both point and nonpoint sources of pollution. Building on a federal investment of \$45.2 billion, the state CWSRFs have provided \$138 billion to communities through 2019. States have provided 41,234 low-interest loans to protect public health, protect valuable aquatic resources, and meet environmental standards benefiting hundreds of millions of people. EPA provides grants to all 50 states plus Puerto Rico to capitalize CWSRF programs and states contribute an additional 20 percent match to the federal grants.

The 51 CWSRF programs function like environmental infrastructure banks by providing low-interest loans and other assistance to eligible recipients for water infrastructure projects. As payments of loan principal and interest earnings are paid back into the state's revolving fund, the state makes new loans to other recipients for high priority water quality activities. In addition, beginning in 2009 Congress authorized the CWSRFs to provide further financial assistance through additional subsidization such as grants, principal forgiveness, and negative interest rate loans.

Financial Reporting Systems for the CWSRF

The CWSRF National Information Management System

EPA collects data annually from the state CWSRF programs to document program progress and account for the use of federal funds. Data collected from the CWSRF programs are stored in the CWSRF National Information Management System (NIMS). Available reports provide national, regional, and state-by-state information on the sources of funds for the CWSRF programs and the way these funds are used for a range of water quality protection projects. These reports include funds from the federal capitalization grants, required state match, bond issuances, and loan repayments. It should be noted that the reporting cycle for NIMS is from July 1 to June 30 (e.g., 2019 information includes funding from July 1, 2018 through June 30, 2019). The CWSRF Clean Water Benefits Reporting System

To compile data on specific loans, EPA collects information on a quarterly basis through its Clean Water Benefits Reporting (CBR) System. Reporting in CBR was first implemented in 2005 on a voluntary basis and later required in 2010. CBR allows EPA to generate summaries on specific loans as well as the environmental benefits they produce. These benefits can be summarized based on the type of discharge, compliance status, or status of the impacted waterbody.

EPA is currently in the process of updating its CBR system to better reflect reporting needs and integrate it with NIMS. This update will include a mapping tool with new data fields and the ability to collect information on individual projects and not just loans. These updates will make it easier to identify water reuse projects. Pending these improvements, the information presented here is based on the current CBR system.

Water Reuse in NIMS and CBR

Information on the types of projects funded is generally categorized according to the definitions used in the Clean Watersheds Needs Survey (CWNS). In NIMS and CBR, the category encompassing water reuse is slightly different than the category in the CWNS and is defined as "the costs associated with the conveyance of treated wastewater that is being reused (recycled water), including associated rehabilitation/replacement needs. Examples include distribution lines and equipment for application of effluent. The costs associated with additional unit processes to increase the level of treatment to potable or less than potable but greater than that normally associated with surface discharge needs are reported as Advanced Treatment". Because this definition includes only conveyance, the number of assistance agreements and dollar amount of assistance going to water reuse likely is understated. However, this is a useful indicator for trends in how water reuse has been supported by the CWSRF. While EPA and its contractors provide technical support for data entry, it should be noted that this data is self-reported by the states. Therefore, there may be variations in how states report data.

There are plans in place to modify the definition of water reuse in NIMS and CBR to align with the definition in the CWNS so it is inclusive of additional treatment for the purpose of water reuse. However, the information presented in this document is reflective of the current definition.

Support for Water Reuse from the CWSRF

CWSRF Financial Assistance for Water Reuse




Figure 1. CWSRF Recycled Water Distribution Assistance

Figure 1 shows the amount of CWSRF assistance that the states have provided for recycled water distribution projects since the program's inception in 1988. It includes the annual assistance provided as well as the cumulative assistance from prior years. In total, over \$1.6 billion in assistance has been provided with the majority of that assistance coming from California, Florida, and Texas. More detailed information on state-level assistance can be found in **Appendix A**.

CWSRF Assistance Agreements for Water Reuse




Figure 2. CWSRF Recycled Water Distribution Assistance Agreements

Figure 2 shows the number of assistance agreements that the states have entered into for recycled water distribution projects since the program's inception in 1988. It includes the annual number of assistance agreements as well as the cumulative number of agreements from prior years. In total, there have been 326 assistance agreements funding recycled water distribution. It should be noted that an assistance agreement refers to the individual financial agreement that recipients enter into with the state CWSRF programs. The number of assistance agreements do not necessarily equal the number of projects because one project can be funded by multiple assistance agreements and a single assistance agreement can fund multiple projects. More detailed information on assistance agreements from each state can be found in **Appendix A**. Information on specific assistance agreements is also available in the CBR database and a list of water reuse agreements funded by the CWSRF can be found in **Appendix B**.

These amendments can change the amount of funding in an assistance agreement or reallocate funds to a different needs category.

Appendix B

Individual Water Reuse Assistance Agreements from the CWSRF Program

The following table shows the recipients of CWSRF assistance based on specific assistance agreements submitted into the Clean Water Benefits Reporting (CBR) system. It should be noted that reporting in CBR has only been available since 2005 and was not made mandatory until 2010. Some states have entered agreements from before 2005 into CBR, but this list may not be complete. This list includes the state, borrower name, the year the assistance was agreed to, total assistance amount, amount of total assistance in the form of additional subsidization, and amount of assistance dedicated to water reuse. CWSRF projects can have more than one component (e.g., water reuse and advanced treatment) and each agreement can be divided into the amount of funding dedicated to each component. Components are largely defined according to the Clean Watersheds Needs Survey and other priorities, and with 26 different possible components only water reuse is included here.
