SCA Hiring Calumet Conservation Corps Tree Crew

The SCA is seeking [Crew Members](#), ages 18-25, and a [Crew Leader](#) (age 21+) from in and around Northwest Indiana to plant and water 1,000 trees in the communities of East Chicago, Hammond, and Gary. Crew Members will collaborate with a team to perform tree planting and watering as green stormwater infrastructure and habitat enhancement in their communities. Crew Members work outdoors seven hours a day, Tuesday through Saturday, for 36 weeks. The Crew Leader works 40 hrs/week for 38 weeks. Positions will be filled on a rolling basis.

The USFWS's Coastal Program is focused on on-the-ground coastal habitat restoration, enhancement, and protection that benefits fish and wildlife. *Award Ceiling: \$500,000. Match recommended but not required.
Projects requesting \$50 - \$150,000 are desirable.

*Deadline: Projects accepted on a rolling basis, preferred by February 19th.

Environmental Justice Small Grants

The EJSG program awards grants that support community-driven projects designed to engage, educate, and empower communities to better understand local environmental and public health issues and develop strategies for addressing those issues, building consensus in the community, and setting community priorities. Potential applicants are invited to participate in one of several [Informational Pre-Application Assistance Conference Calls](#) scheduled in December and January.

*Award ceiling: \$30,000.

*Applications due: February 15, 2019.
