## NOTICE OF FINAL PERMIT DECISION

Issuance of the Class I Non-Hazardous Permit No. R9UIC-CA1-FY17-4
For Chalk Cliff Limited
September 29, 2020

In accordance with the requirements of the Code of Federal Regulations (CFR), Title 40, §124.15, the United States Environmental Protection Agency, Region 9 (EPA) is issuing a Class I Non-Hazardous Underground Injection Control (UIC) Permit, No. R9UIC-CA1-FY17-4, to Chalk Cliff Limited for an existing injection well, Chalk Cliff WD-2. EPA is also issuing the response to comments, pursuant to 40 CFR §124.17. The response to comments responds to all significant comments received by EPA during the public comment period. The final UIC permit, EPA's Response to Comments document, and a copy of this notice are available on EPA's web page at <a href="https://www.epa.gov/uic/uic-permits-pacific-southwest-region-9">https://www.epa.gov/uic/uic-permits-pacific-southwest-region-9</a>.

EPA opened the public notice period of the draft UIC permit on August 16, 2020. The public comment period ended on September 16, 2020. The final permit decision will be effective on October 31, 2020 in accordance with 40 CFR §124.15(b)(1), unless review is requested on the permit under the appeal process at 40 CFR §124.19.

Any person who filed comment on the Draft Permit may petition the Environmental Appeals Board (EAB) to review any condition of the permit decision under 40 CFR §124.19(a) within 30 days after service of this notice of EPA's final permit decision. See 40 CFR §124.19 for the procedural requirements of the appeal process. You may file documents with the EAB electronically, by mail, in person, and in limited circumstance, by facsimile. Information and instructions on how to file your documents electronically are available in the "Electronic Filing" section on the EAB Website.
