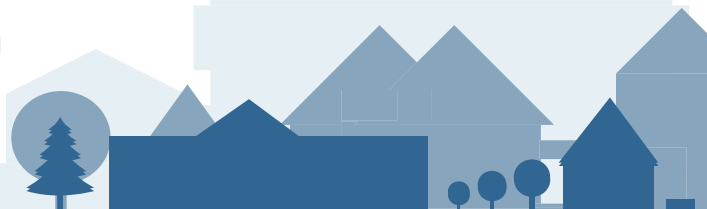

Our Statutory Authority

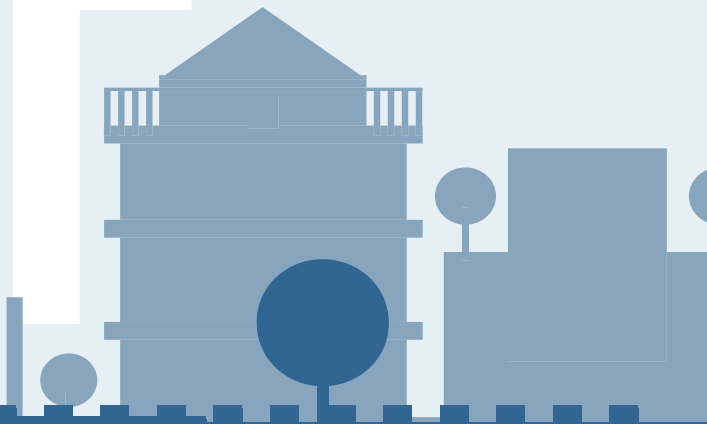
EPA's Asbestos Ombudsman

Mandated under the Asbestos Hazard Emergency Response Act (AHERA) (15 U.S.C. § 2641-2656).

EPA's Small Business Ombudsman

Established under Section 507 of The 1990 Clean Air Act amendments (42 U.S.C. § 7661f(d)).

As a related responsibility, the ASBO program supports the Agency in considering small business impacts within the rule development process as required under the Small Business Regulatory Enforcement Fairness Act (SBREFA).

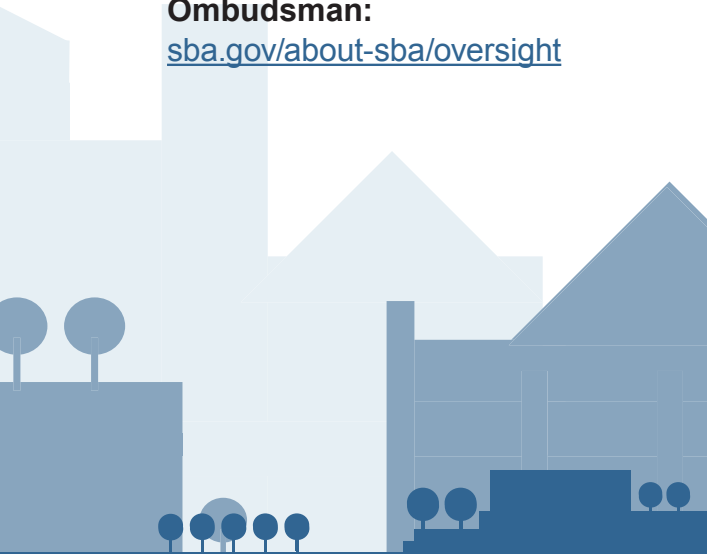
