Petition for Three Year Extension of Exclusive Data Use for Flutriafol

(Per FIFRA Section 3(c)(1)(F)(ii))

Dear Ms. Johnson:

FMC Corporation respectfully petitions EPA to extend the period of exclusive data use for Flutriafol fungicide by three years, by applying the provision listed under FIFRA Section 3(c)(1)(F)(ii).

FMC believes that Flutriafol meets the criteria required for this provision based on currently registered uses on minor crops. Uses were attainted through the EPA review and approval process within the first seven years following the initial registration (April 29, 2010) for these crops and crop groups which contain minor uses.

- Leafy vegetables, except Brassica, crop group 4 (with 4 representative crops: head lettuce, leaf lettuce, spinach, and celery)
- Brassica leafy vegetables crop group 5 (with 3 representative crops: broccoli or cauliflower, cabbage, and mustard greens)
- Cucurbit Vegetables crop group 9 (with 3 representative crops: cucumber, muskmelon, and summer squash)
- Fruiting vegetable crop group 8-10 (with 3 representative crops: tomato and pepper (bell and non-bell))
- Pome fruit crop group 11 (with 2 representative crops: apple and pear)
- Stone fruit crop group 12 (with 3 representative crops: cherry, peach, and plum)
- Tree nut crop group 14 (with 2 representative crops: almond and pecan)

- Strawberry
- Popcorn
- Hops

Based on the justification provided in the enclosed data exclusivity extension petition (MRID 51124701), the criteria are met to qualify for three additional years of exclusivity.

This registration action is classified as a PRIA action M007 with a fee \$5,789.
