Ancestral Lands Policy

- Statement of Administration Policy
   on Native American Ancestral Lands
- Issued on September 25, 2020
- Policy of this administration to encourage every state agency, department, board and commission to seek opportunities to support California Tribes' co-management and access to natural lands that are with a California Tribes' natural land and under the ownership or control of the state of California

# SGMA – Sustainable Groundwater Management Act Technical Review


- Process of review of GSPs for the state's critically overdrafted basins (COB) submitted in Jan 2020 to ensure they meet requirements
- Assess and evaluate GSPs to determine plans are adequate and will likely meet the basin's sustainability goals over the 20-year planning horizon of SGMA
- DWR has two years from date of submission to assess the COB plans (Jan 31, 2022 latest)

## SGMA – Ongoing Assistance

- DWR will continue providing planning, technical, and financial assistance for all GSAs through GSP development into plan implementation
- GSAs should continue to move forward with implementation of their plans, and provide their annual reports and five-year plan updates to DWR as required as by SGMA
- High/Med Priority Basins GSPs due Jan 2022

## SGMA – Guidance Document

- Engagement With Tribal Governments
- intended to provide general guidance to GSAs regarding how and when to engage with Tribal governments
- Developed through SGMA Tribal Advisory Group
- Government to Government Relationship building



# IRWM – Integrated Regional Water Management

- Round 1 funding has been awarded (June 2020)
- Round 2 Grant Solicitation
- The remaining funds will be awarded in a second implementation funding round
- Grant Proposal Solicitation Package (late 2021)

# IRWM – Funding Regions

- Prop 1 designated 12 funding regions (2014)
- 48 self-defined IRWM regions in California
- Prop 1 allocated \$510 million to the 12 funding areas
- Each funding areas was required to conduct a needs assessment
- DACTI established 2016 and provided \$51.7 million

Early findings of Prop 1 DAC/DACTI funds (\$52m)

# IRWM – Tribal Hurdles in Participation Can be Overcome

- CEQA / NEPA issues on Tribal Land
- Audit and Access to project location(s)
- State / Federal prevailing wage issues
- Limited waivers of sovereign immunity
  - Resolution through Government-to-Government consultation

# DCP - Tribal Cultural Resources Identification Process

- DWR conducting ethnographic research to identify locations in the DCP project area with potential significance
- Consultation with Tribes to identify places with cultural significance to a California Native American Tribe
- DWR includes the information from consultation for California Register evaluation of potential TCRs
- DWR will develop a Tribal Cultural Resources Evaluation Report with Tribal Input and Review
