Monday – May 10, 2021

Not On-Site

Tuesday – May 11, 2021

Received equipment. Inspected site and noted areas that will require pumping water down. Planned erosion repair areas, identified areas for repair are Surface Cover Area 3 and Soil Removal Area 4. Began grading Soil Removal Area 3 and pumped water out of Soil Removal Areas 1 and 4.

Wednesday - May 12, 2021

Continued pumping water out of Soil Removal Areas 1 and 4 and grading in Soil Removal Area 4. Removed metal fence posts and snow fence from road side of Soil Removal Area 1. Inspected ruts in Surface Cover Area 3 and Soil Removal Area 3 and transition zone from Surface Cover Area 2 to Surface Cover Area 3.

Thursday - May 13, 2021

Continued pumping water out of Soil Removal Areas 1 and 4 and began pumping water from Soil Removal Area 2. Continued grading in Soil Removal Areas 3 and 4. Began erosion repair in Surface Cover Area 3. Installed geotextile in Soil Removal Area 4.

Friday - May 14, 2021

Continued pumping water out of Soil Removal Areas 1 and 2 and Surface Cover Area 1. Continued grading in Soil Removal Areas 3 and 4. Continued erosion repair in Surface Cover Area 3. Regraded transition areas between Surface Cover Areas 1 and 2 and Surface Cover Areas 2 and 3. Placed fill in

eroded areas in Soil Removal Area 4 and Surface Cover Area 3. Installed erosion control matting and filter sock in Soil Removal Area 4 over eroded areas.

Saturday – May 15, 2021

Continued pumping water out of Soil Removal Areas 1 and 2 and Surface Cover Area 1. Repaired and regraded eroded areas in Soil Removal Area 1 in the southwest corner and Soil Removal Area 2.

Sunday - May 16, 2021

Not On-Site

Monday - May 17, 2021

Continued pumping water out of Soil Removal Area 1. Removed previously installed erosion control matting from eroded areas in Soil Removal Area 4, regraded two repaired areas, and installed non-woven geotextile, erosion control matting, and stone. Continued installing erosion control matting in ditch in northeast corner of Surface Cover Area 1.

Tuesday – May 18, 2021

No seeding today due to rain.

Wednesday – May 19, 2021

No seeding today due to rain from yesterday. Completed erosion repairs in Soil Removal Area 4 including stone and erosion control matting placement. Placed lime and fertilizer in Soil Removal Area 4. Installed erosion control matting in Surface Cover Area 3 in location of erosion repair. Repaired potholes in site access roads and cleaned up debris from Soil Removal Area 4.

Thursday - May 20, 2021

Pumped water out of Soil Removal Area 1 and Surface Cover Area 1 south and western ditches. Repaired ruts in Surface Cover Area 1. Initiated hydroseeding of Soil Removal Area 4 with wetland seed mix.

Friday - May 21, 2021

Completed pumping water out of Surface Cover Area 1. Placed wetland seed mix in ditches and wetland areas of Soil Removal Area 3 and Surface Cover Area 1, 2, and 3. Began upland seed mix application in Soil Removal Area 4 and Surface Cover Area 3.

Saturday – May 22, 2021

Completed erosion control matting stapling. Continued hydroseeding in Soil Removal Area 3 and Surface Cover Areas 2 and 3. Spread fertilizer in Surface Cover Areas 1, 2, and 3 and Soil Removal Area 1 wetland areas. Applied wetland seed mix in the southern portion of Soil Removal Area 1. Installed filter socks across Soil Removal Area 4 access road.

Sunday - May 23, 2021

Completed hydroseeding Surface Cover Areas 2 and 3 and started hydroseeding Surface Cover Area 1. Applied wetland seed mix in northern wetland area in Soil Removal Area 1.

Monday - May 24, 2021

Completed hydroseeding in Surface Cover Area 1. Repaired ruts and reseeded areas that were repaired by hand. Cleared aggregate from ditch line at site entrance. Began demobilization of equipment from Site.
