This is our response letter to your Freedom of Information Act (FOIA) request dated August 10, 2010, as clarified in your August 20, 2010, phone conversation with Associate Regional Counsel Maria Gonzalez, documented in an August 27, 2010 Email. On September 8, 2010, you agreed to an extension until September 17, 2010, to respond.

Your August 10, 2010 request seeks documents related to the U. S. Environmental Protection Agency's review or approval of general permits by rule in Indiana for various source sectors. Those source sectors and discharges permitted by Indiana Department of Environmental Management (IDEM) include:

- Rule 5, Construction Stormwater,
- Rule 6, Industrial Stormwater,
- Rule 7, Coal mining,
- Rule 8, Noncontact cooling water
- Rule 9, Petroleum Product terminals,
- Rule 13, Stormwater discharges associated with Municipal Separate Storm sewers, and
- Rule 14, Concentrated Animal Feeding Operations.
