  - Collected water levels, surface water samples, and groundwater samples (summer event during base flow conditions) as outlined in correspondence to NJDEP/USEPA on March 27, 2019.
- Remedial Action
  - o MW-107R
    - Collected groundwater sample for total organic carbon analysis on June 4, 2019. The concentration was 875 mg/L.

    - > Continued GWETS system operation.
    - > Conducted monthly sampling of system influent and effluent.
    - > Collected quarterly water level measurements from monitoring wells and piezometers.
