MOVES3.0.2

- Was released September 13th and described in an email to the MOVES listsery
- Is considered a "patch" to MOVES, since the impact on emissions is very small
 - It is not considered a new model for State Implementation Plan (SIP) and transportation conformity regulatory purposes
- Addresses a variety of small issues
 - Includes change that increases Tier 4 nonroad diesel PM emissions
 - While the impact on total emissions is small, the percentage change may be large
