# Summary of Early Engagement with our Partners for the FY 2023-2024 OLEM National Program Guidance

# Process for Soliciting Early Input

Between July and October 2021, OLEM conducted outreach to its partners to inform the FY 2023-2024 OLEM National Program Guidance. During this time, OLEM program offices held conference calls and web-based meetings with state, tribal and local partners to discuss priorities and other important issues. # Highlights of Early Input from States, Tribes and Associations

#### **Tribal Concerns**

## Waste Management

- Tribal waste managment trainings/technical assistance such as codes and ordinances development and enforcement, backhaul, recycling, junk car and white goods removal, food waste minimization and microplastics
- Education and outreach on lead, household hazardous wastes and open dumping
- Tribes and EPA project officers should work together to compile potential resources from Brownfields, the state, and regulated entities
- Open dumping from nontribal sources and an inability to enforce codes and ordinances
- Prioritize tribal waste management funding and increase GAP funding
- Provide training to EPA staff on tribal treaties, laws, and cultural sensitivity

#### **Underground Storage Tanks**

- Tribal USTs can play a critical role in emergency response situations
- Clarify federal government's role in IC relative to states

#### Environmental Justice

- Set up a website with tribal success stories regarding EJ concerns
- EJ could be applied to Tribes, but it should not be done at the expense of ignoring treaty. language regarding rights and responsibilities. The Tribes have a right to environmental self-determination

#### General/Funding

- Tribes are sovereign nations, co-regulators and important EPA partners. OLEM should consider inviting tribes to help author and/or contribute to original drafts of documents, where appropriate, to ensure that tribal perspectives and needs are included from the beginning and integrated into the program and not as an afterthought
- Encourage OLEM to empower tribes to engage with programs where tribes can't be delegated primacy
- Tribes advocated for priority funding from Superfund, brownfields, UST remediation, and solid waste

• Lack of equitable funding, e.g., for tribal staffing (re: waste management)

#### **Brownfields**

• State partners expressed enthusiastic support for continuing our coordination and collaboration to advance Brownfields and Land Revitalization goals.

## **Underground Storage Tanks**

- Incorporate equity and inclusion into our work
- Full implementation of the 2015 underground storage tank regulations

### **Federal Facilities**

Input was provided ranking state federal facility program priorities:

- 1. Applicable or Relevant and Appropriate Requirements (ARARs)
- 2. Contaminants of Emerging Concerns/PFAS
- 3. Munitions Response
- 4. Formerly Used Defense Sites (FUDS)
- 5. Long-term stewardship/Land Use Controls (LUCs)/Institutional Controls (ICs)

State priorities also are further detailed in the May 2020 Federal Facilities Issues Paper
