Attached are the final allotments for the FY2021 *Voluntary Lead Testing in School and Child Care Program Drinking Water Grant* Program. This memo supersedes the attached allotment table in the FY2021 allotment memo dated March 15, 2021.

Congress authorized this grant program under section 2107 of the Water Infrastructure Improvements for the Nation Act (WIIN Act). The total amount available for this program is \$26,500,000 for participating states, territories and tribes. Attached are the final allotments for states and territories and the amount available to support tribal education agencies.

Current grantees are expected to work with the U.S. Environmental Protection Agency regional offices to confirm their continued intention to participate in the WIIN 2107 Grant program. If any of the entities listed in the attached table elect not to participate in the program, the funding will be reallocated to participating entities, and the EPA will provide updated allotments.
