SUBJECT: Allotments of FY2020 Appropriations for the Voluntary Lead Testing in School and Child Care Program Drinking Water Grants, Authorized under Section 2107 of the Water Infrastructure Improvements for the Nation Act

Attached is the FY2020 *Voluntary Lead Testing in School and Child Care Program Drinking Water Grant* Program allotments. Congress authorized this grant program under section 2107 of the Water Infrastructure Improvements for the Nation Act (WIIN Act). The total amount available for this program is \$26,000,000 for participating states, territories and tribes. Attached are the current allotments and the amount available to support tribal education agencies.

Current grantees are expected to work with the U.S. Environmental Protection Agency (EPA) regional offices to confirm their continued intention to participate in the program. The EPA regional offices are reaching out to the eligible entities that did not participate in the first year of the program regarding the opportunity to participate in FY2020. New grantees must provide a notification of intention to participate (NOIP) to the EPA by May 4, 2020. If any of the entities listed in the attached table elect not to participate in the program, the funding will be re-allocated to participating entities, and the EPA will provide updated allotments.

A webinar will be scheduled to provide information on the grant and lead in drinking water testing using EPA's 3Ts toolkit in March 2020.
