Dear Mr. Martinez:

I am writing to inform you that the U.S. Environmental Protection Agency has finalized a list of additional areas subject to the mitigation plan requirements found in the 2016 Exceptional Events Rule and codified at 40 CFR 51.930. The EPA has determined that Bernalillo County, New Mexico has frequently recurring exceptional events of the same type and pollutant as shown in the enclosed table. The process that the agency followed to identify additional areas subject to mitigation plans and the required components of mitigation plans is contained in the enclosed background document, in the docket established for this rulemaking, Docket ID No. EPA-HQ-OAR-2022-0313, and on the EPA's Exceptional Events web site at https://www.epa.gov/air-quality-analysis/treatment-air-quality-datainfluenced-exceptional-events-homepage-exceptional.

Although tremendous progress has been made to improve air quality across the nation, climate change conditions make it more challenging to attain national air quality standards and to protect public health. Over the last few years, we have experienced more frequent and intense weather conditions and more adverse impacts from wildfire smoke and windblown dust on communities. As you develop your mitigation plan, we strongly encourage you to evaluate and incorporate measures that can be taken under your authority to mitigate PM₁₀ emissions in all communities including vulnerable and disproportionately impacted communities.

Section 319(b) of the Clean Air Act expresses Congress' intent that, in promulgating the Exceptional Events Rule, the protection of public health be the highest priority. The EPA believes fulfilling its obligation to identify additional areas with historically documented or recurrent exceptional events is an important step in fulfilling the agency's mission to protect public health and the environment.
