Re: Notification of Continued Consultation and Coordination on the Draft Clean Water Act Section 106 Tribal Grant Guidance

Dear Honorable Leader,

The U.S. Environmental Protection Agency (EPA) is continuing consultation and coordination with federally recognized Indian Tribes on revisions to the Clean Water Act Section 106 Tribal Grants Guidance (Section 106 Tribal Guidance), formerly the *Final Guidance on Awards of Grants to Indian Tribes under Section 106 of the Clean Water Act - 2007 and Beyond.* 

On January 13, 2021, EPA initiated consultation and coordination with Tribes to seek input on recommended changes to the 2007 Section 106 Tribal Guidance. EPA then established a Section 106 Tribal Guidance Revision workgroup, made up of EPA staff and 24 tribal volunteers, to assist in the revisions to the 2007 Guidance. The Section 106 Tribal Guidance Revision workgroup developed draft text based on the initial EPA recommendations and tribal feedback provided through the consultation and coordination process. The list of work group members is attached.

The EPA is pleased to present for your review and comment the draft revised Section 106 Tribal Guidance. The guidance, once finalized, will replace the 2007 Guidance. It is anticipated that Tribes will have until August 15,2022 to comment on draft revised Guidance.

The continuation of the consultation and coordination process for the revision of the Section 106 Tribal Guidance will be conducted in accordance with the *EPA Policy on Consultation and Coordination with Indian Tribes* (<u>https://www.epa.gov/tribal/epa-policy-consultation-and-</u> <u>coordination-indian-tribes</u>). The consultation period for the revision of the Section 106 Tribal Guidance has remained open for the duration of this effort.

Enclosed is a consultation and coordination plan that further describes the process EPA has followed, including a timeline for the remainder of the consultation and coordination period, and information on how you can provide input on this action. *This information is also available on EPA's Tribal Consultation Opportunities Tracking System (TCOTS) at <u>https://tcots.epa.gov</u>.*

# Updated Consultation and Coordination Plan: Review of the Draft Clean Water Act Section 106 Tribal Grants Guidance

# Background Information on the Initiative

Section 106 of the Clean Water Act (CWA) authorizes EPA to provide financial assistance to states, interstate agencies, and eligible Tribes to establish and administer programs for the prevention, reduction, and elimination of water pollution. In 1987, Congress amended Section 518(e) of the CWA to include provisions that allow EPA to treat an Indian Tribe in a manner similar to a state (i.e., treatment in a manner similar to a state, or TAS) for the purpose of providing Section 106 funding.

Since 1987, EPA has provided technical assistance and funding under the CWA Section 106 program to assist Tribes and intertribal consortia to understand, assess, and preserve water resources on their lands. For Tribes, CWA Section 106 grants are a crucial, dedicated source of funds for developing, maintaining, and expanding water quality programs. These programs are designed to control, prevent, and eliminate water pollution as well as to educate tribal members and the public.

Of the 574 federally recognized Tribes, approximately 335 could potentially meet the CWA eligibility requirements for CWA Section 106 funding. To date EPA has determined that 284 Tribes are eligible to receive Section 106 grants.<sup>1</sup>

## Potential Benefits to Tribes

EPA has used the current CWA Section 106 Tribal Guidance since Fiscal Year 2007 as the primary guidance for Section 106 tribal grant recipients and internal and external grant project officers. The goals of revising the CWA Section 106 Tribal Guidance include:

- Develop clear, comprehensive, updated, and succinct language that is relevant and applicable to Tribes.
- Describe the CWA Section 106 program and provide context around the CWA generally.
- Describe the benefits of water quality program development and implementation.
- Provide practical guidance in program implementation.
- Provide consistent messaging on national program requirements to help Tribes negotiate workplans.

The revisions to the Guidance did not develop new policy for the Tribal Water Programs. The national allocation formula was not impacted by the Guidance revision process.

## Initial 60-Day Comment Period

The consultation and coordination period provides Tribes an opportunity to inform the revisions being considered for the CWA Section 106 Tribal Guidance and remains open for the duration of this effort. EPA held the first of two 60-day comment periods from January 13, 2021 – March 14, 2021. During the

Approximately 335 Tribes currently appear to have lands that qualify as reservations as defined in the Act, although an applicant Tribe must provide documentation to EPA concerning its reservation, government, and capabilities to be found eligible.

first comment period, EPA requested tribal feedback on its recommendations for revising the 2007 Guidance.

# Second 60-Day Comment Period - Opportunities for Tribes to Participate

For this second comment period, which is anticipated from June 13, 2022 - August 15, 2022, EPA is seeking input on the draft revised Section 106 Tribal Guidance, and is specifically interested in tribal feedback on the following:

- 1. The Guidance seeks to provide a flexible framework for Tribes to establish and expand their water quality programs. Are there additional flexibilities EPA should consider?
- 2. Indigenous Traditional Ecological Knowledge (ITEK) is a new addition to the Guidance. Do you have feedback on the language provided?
- 3. The Guidance retains the three existing programmatic requirements: Monitoring Strategy, Data submission, and Assessment. The Guidance proposes a new requirement for Tribes to provide data directly to WQX in recognition of the progress tribal water quality programs have made over the last 15 years. However, for Tribes that are not currently able to provide data directly to WQX the requirement is to provide the data in a WQX compatible format along with a request for a waiver that provides Tribe-specific information on existing barriers to flowing data. What tools and technical assistance should EPA make available to support tribal data flow?
- 4. The Guidance should be specific without being overly detailed. Should any of the content be removed and replaced with a link to find more information? If so, please specify what content you suggest removing.
- 5. The Guidance should be brief but detailed enough to cover all necessary topics. Should any of the content be expanded upon with more information? If so, please specify what content you suggest expanding.

EPA is also interested in highlighting more examples of tribal programs experience developing and managing their CWA Section 106 funded water quality programs

Once EPA evaluates and considers tribal comments from this second comment period, EPA plans to finalize the CWA Section 106 Tribal Guidance. Once finalized, the revised Guidance will replace the 2007 Guidance.

EPA looks forward to working with federally recognized Tribes to better understand their needs and answer questions related to the recommended revisions to the CWA Section 106 Tribal Guidance.
