Contributor Account Benefits



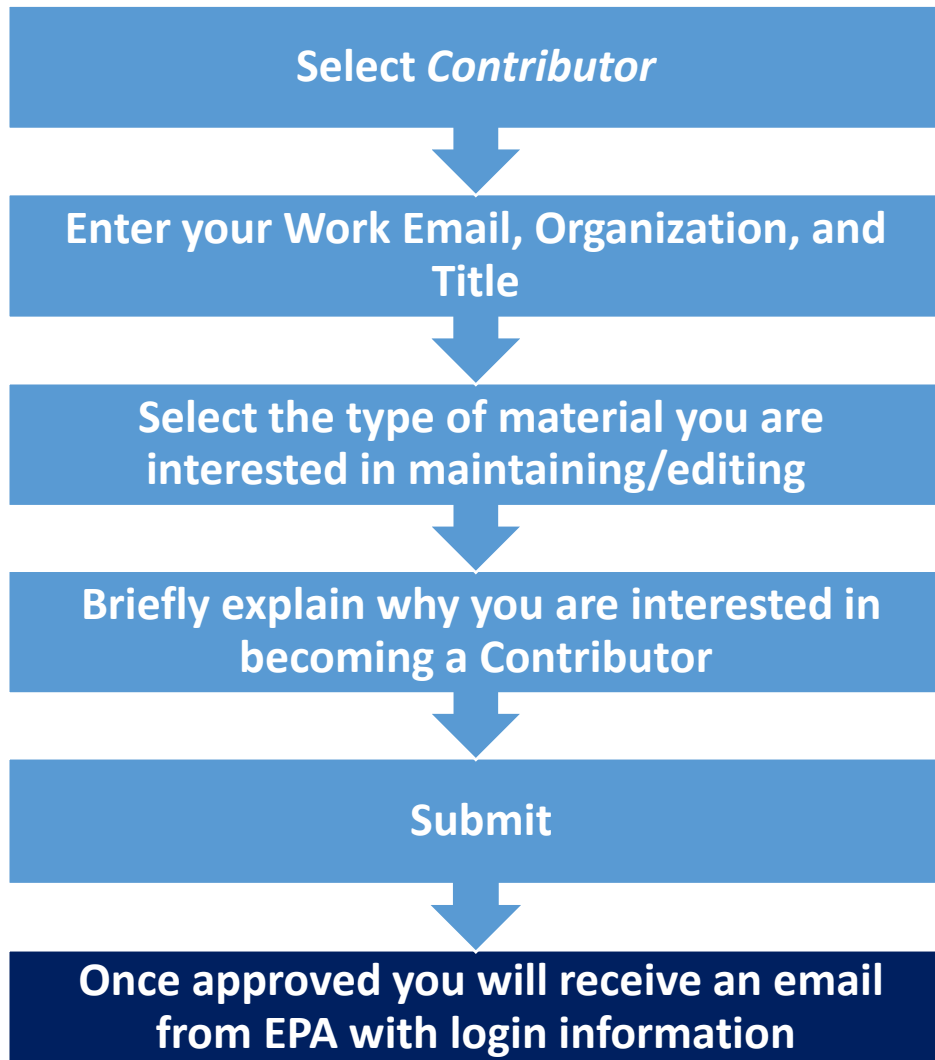
General User resource suggestions are limited to providing a URL and comments.
