#### I. CONSENT AGREEMENT

# A. Preliminary Statement

This is a civil administrative penalty assessment proceeding brought under section
 205(c)(1) of the Clean Air Act ("CAA" or the "Act"), 42 U.S.C. § 7524(c)(1), and sections 22.13
 and 22.18 of the Consolidated Rules of Practice Governing the Administrative Assessment of
 Civil Penalties and the Revocation/Termination or Suspension of Permits ("Consolidated

Rules"), as codified at 40 C.F.R. Part 22. In accordance with 40 C.F.R. §§ 22.13 and 22.18, entry of this Consent Agreement and Final Order ("CAFO") simultaneously initiates and concludes this matter.

- 2. Complainant is the Director of the Air, Waste & Chemicals Branch of the Enforcement and Compliance Assurance Division, U.S. Environmental Protection Agency Region IX (the "EPA"), who has been delegated the authority to initiate and settle civil administrative penalty proceedings under section 205(c)(1) of the CAA, 42 U.S.C. § 7424(c)(1). EPA Delegation 7-19 (January 18, 2017); EPA Region 9 Redelegation R9-7-19 (October 5, 2017); Memorandum from John W. Busterud, Regional Administrator, Region 9, to all Region 9 supervisors and employees re: EPA R9 Organizational Realignment General Redelegation of Authority (May 5, 2020).
- 3. Pursuant to section 205(c)(1) of the CAA, 42 U.S.C. § 7424(c)(1), and 40 C.F.R. § 19.4, the EPA and the Department of Justice jointly determined that an administrative penalty proceeding is appropriate, for this matter, although the penalty assessment is above \$390,092<sup>1</sup>. 4. Respondent is Allied Exhaust Systems, Inc. dba Team Allied Distribution ("Allied"), a California corporation distributing motor vehicle parts. Allied is headquartered at 3928 Oregon St. in Benicia, California.
- 5. Complainant and Respondent, having agreed that settlement of this action is in the public interest, consent to the entry of this CAFO without adjudication of any issues of law or fact herein, and Respondent agrees to comply with the terms of this CAFO.

# **B.** Governing Law

- 6. This proceeding arises under Part A of Title II of the CAA, CAA §§ 202-219, 42 U.S.C. §§ 7521-7554, and the regulations promulgated thereunder. These laws aim to reduce emissions from mobile sources of air pollution, including hydrocarbons and oxides of nitrogen ("NOx").
- 7. Section 203(a)(3)(B) of CAA, 42 U.S.C. § 7522(a)(3)(B), prohibits any person from manufacturing, selling, offering to sell, or installing parts or components where a principal effect is to bypass, defeat, or render inoperative a motor vehicle emission control device or element of design, where the person knows or should know that the part is being offered for sale or installed for such use.
- 8. Violations of CAA section 203(a)(3)(B) are subject to civil penalties of up to \$5,179 per defeat device violation that occurred after November 2, 2015, where penalties are assessed on or after January 12, 2022. Section 205 of the CAA, 42 U.S.C. § 7524 and 40 C.F.R. Part 19.

#### 9. Definitions:

- a. Section 302(e) of the CAA, 42 U.S.C. § 7602(e), defines "person" as "an individual, corporation, partnership, association, State, municipality, political subdivision of a State, and any agency, department, or instrumentality of the United States and any officer, agent or employee thereof."
- b. Section 216(2) of the CAA, 42 U.S.C. § 7550(2), defines "motor vehicle" as "any self-propelled vehicle designed for transporting persons or property on a street or highway."
- 10. The CAA requires EPA to prescribe and revise, by regulation, standards applicable to the emission of any air pollutant from new motor vehicles or new motor vehicle engines which cause

or contribute to air pollution, which may reasonably be anticipated to endanger public health or welfare. CAA §§ 202(a)(l) and (3)(B), 42 U.S.C. §§ 7521(a)(l) and (3)(B).

- 11. Highway motor vehicles are one category of motor vehicles for which the EPA has promulgated emission standards. <u>See</u> 42 U.S.C. § 7521; <u>see generally</u> 40 C.F.R. Part 86.
- 12. Highway motor vehicle manufacturers employ many devices and elements of design to meet these emission standards. Certain hardware devices serve as emission control systems to manage and treat exhaust from highway motor vehicles in order to reduce levels of regulated pollutants from being created or emitted into the ambient air. Such devices include catalytic converters.

## C. Alleged Violations of Law

- 13. Respondent sells and distributes motor vehicle parts to various individual customers located throughout the United States.
- 14. On August 28, 2019, EPA sent an information request pursuant to section 208(a) of the CAA, 42 U.S.C. § 7542(a), to Respondent regarding hardware and tuners that Respondent sold since January 1, 2018.
- 15. On August 12, 2020, EPA sent a follow-up information request pursuant to section 208(a) of the CAA, 42 U.S.C. § 7542(a), to Respondent.
- 16. Based on Respondent's responses on September 26, 2019, November 15, 2019, and September 25, 2020 to EPA's information requests and additional information gathered during EPA's investigation, EPA alleges that Allied sold 3,748 exhaust emission control delete pipes ("subject delete pipes"), 767 aftermarket electronic control module ("ECM") programmers ("subject tuners") and 12 exhaust gas recirculation delete hardware ("subject EGR delete

hardware") for highway motor vehicles identified in Appendix A of this CAFO (collectively referred to as the "Devices").

- 17. The subject delete pipes do not incorporate exhaust aftertreatment emission control devices and are designed to replace exhaust systems containing catalytic converters, diesel oxidation catalysts ("DOCs"), diesel particulate filters ("DPFs"), nitrogen oxide absorbing catalyst ("NACs"), and selective catalytic reduction ("SCRs").
- 18. The subject tuners render inoperative the original equipment manufacturer ("OEM")-certified ECM programming and replace them with programming that alters fuel injection and other elements of design that can lead to significant emission increases compared to the OEM-certified programming. These aftermarket tuners also defeat the OEM-certified ECM programming by overriding the onboard diagnostic system ("OBD") functions required by regulation under the CAA. The tuners enable removal of DPF without illuminating a malfunction indicator lamp ("MIL"), prompting any diagnostic trouble code ("DTC"), or causing any engine derating.
- 19. The subject EGR delete hardware replaces and removes the EGR valve and cooler systems found on newer diesel and gas engines from highway motor vehicles for which they are designed. The hardware typically include air intake manifolds and/or exhaust up pipes that replace the EGR valve and/or cooler, and that do not include an EGR port, resulting in the disablement of the EGR system.
- 20. Hardware devices and emission control systems, such as EGRs, are "device[s] or element[s] of design installed on or in a motor vehicle or motor vehicle engine in compliance with [CAA] regulations" within the meaning of section 203(a)(3)(B) of the CAA, 42U.S.C. § 521(a)(3)(B).

- 21. Each subject delete pipe, subject tuner, and subject EGR delete hardware part is, and at all relevant times herein was, intended for use with certified motor vehicles and motor vehicle engines including Ford Motor Company ("Ford"), Fiat Chrysler Automobiles US LLC ("Chrysler Dodge"), General Motors Company ("GMC"), and Honda Motor Corporation ("Honda") vehicles ("Motor Vehicles").
- 22. A principal effect of each subject delete pipe, subject tuner, and subject EGR delete hardware part is to bypass, defeat, or render inoperative device(s) and/or element(s) of design such as the EGR that was installed on these Motor Vehicles.
- 23. Respondent knew or should have known that each subject delete pipe, subject tuner, and subject EGR delete hardware part was being offered for sale or installed for such use or put to such use.
- 24. Between January 1, 2018 and August 28, 2019, Allied sold 4,527 Devices to individual customers located throughout the United States.
- 25. The manufacture, sale, offering for sale, or installation of a device that bypasses, defeats, or renders inoperative a vehicle's emission control systems is prohibited under section 203(a)(3)(B) of the CAA, 42 U.S.C. § 7522(a)(3)(B).
- 26. Allied has committed approximately 4,527 violations of section 203(a)(3)(B) of the CAA, 42 U.S.C. § 7522(a)(3)(B), by manufacturing, selling, or offering for sale the Devices.

#### **D.** Terms of Consent Agreement

- 27. For the purpose of this proceeding, as required by 40 C.F.R. § 22.18(b)(2), Respondent:
  - a. admits that EPA has jurisdiction over the subject matter alleged in this CAFO and over Respondent;

- b. neither admits nor denies the specific factual allegations contained in Section I.C of this CAFO;
- c. consents to the assessment of a civil penalty under this Section, as stated below;
- d. consents to the conditions specified in this CAFO;
- e. waives any right to contest the allegations set forth in Section I.C of this CAFO; and
- f. waives their rights to appeal the proposed Order contained in this CAFO.

#### E. Civil Penalty

## 28. Respondent agrees to:

- a. pay the civil penalty of ONE MILLION ONE HUNDRED THOUSAND
   DOLLARS (\$1,100,000) ("EPA Penalty") within 30 days of the Effective Date of this CAFO; and
- b. pay the EPA Penalty using any method, or combination of methods, provided on the website https://www.epa.gov/financial/makepayment, and identifying the payment with "Docket No. CAA-09-2022-0022." Within 24 hours of payment of the EPA Penalty, send proof of payment to Janice Chan at chan.janice@epa.gov and the Regional Hearing Clerk at r9hearingclerk@epa.gov ("proof of payment" means, as applicable, a copy of the check, confirmation of credit card or debit card payment, confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate the payment has been made according to the EPA requirements, in the amount due, and identified with "Docket No. CAA-09-2022-0022").

- 29. If Respondent does not timely pay the civil penalty, specified in Paragraph 28, then Respondent shall pay to the EPA a stipulated penalty in the amount of FIVE HUNDRED DOLLARS (\$500.00) for each day the default continues plus the remaining balance of the penalty sum specified in Paragraph 28 upon written demand by the EPA.
- 30. If Respondent fails to timely pay any portion of the penalty assessed under this CAFO, the EPA may:
  - a. request the Attorney General to bring a civil action in an appropriate district court to recover: the amount assessed; interest at rates established pursuant to 26 U.S.C. 
    § 6621(a)(2); the United States' enforcement expenses; and a 10 percent quarterly nonpayment penalty, 42 U.S.C. § 7413(d)(5);
  - b. refer the debt to a credit reporting agency or a collection agency, 42 U.S.C. § 7413(d)(5), 40 C.F.R. §§ 13.13, 13.14, and 13.33;
  - c. collect the debt by administrative offset (i.e., the withholding of money payable by the United States to, or held by the United States for, a person to satisfy the debt the person owes the Government), which includes, but is not limited to, referral to the Internal Revenue Service for offset against income tax refunds, 40 C.F.R. Part 13, Subparts C and H; and
  - d. suspend or revoke Respondent's licenses or other privileges granted by EPA, or suspend or disqualify Respondent from doing business with EPA or engaging in programs EPA sponsors or funds, 40 C.F.R. § 13.

#### F. Certification of Compliance

31. Respondent certifies that as of the date of their signature of this Consent Agreement, Respondent is complying fully with section 203(a)(3) of the CAA, 42 U.S.C. § 7522(a)(3).

- 32. Respondent is aware of EPA's November 23, 2020 "Tampering Policy: The EPA Enforcement Policy on Vehicle and Engine Tampering and Aftermarket Defeat Devices under the Clean Air Act."
- 33. The provisions of this CAFO shall apply to and be binding upon Respondent and their officers, directors, employees, agents, trustees, servants, authorized representatives, successors, and assigns. In the period before Respondent satisfies the obligations set forth in Paragraph 28, Respondent must give written notice and a copy of this CAFO to any successors in interest prior to any transfer of ownership or control of any portion of or interest in Respondent.

  Simultaneously with such notice, Respondent shall provide written notice of such transfer, assignment, or delegation to EPA. In the event of any such transfer, assignment, or delegation, Respondent shall not be released from the obligations or liabilities of this CAFO unless EPA has provided written approval of the release of said obligations or liabilities.
- 34. By signing this CAFO, Respondent acknowledges that this CAFO will be available to the public and agrees that this CAFO does not contain any confidential business information or personally identifiable information.
- 35. By signing this CAFO, the undersigned representative of Complainant and the undersigned representative of Respondent each certify that he or she is fully authorized to execute and enter into the terms and conditions of this CAFO and has the legal capacity to bind the party he or she represents to this CAFO.
- 36. By signing this CAFO, Respondent certifies that the information they have supplied concerning this matter was at the time of submission true, accurate, and complete for each such submission, response, and statement. Respondent acknowledges that there are significant

penalties for submitting false or misleading information, including the possibility of fines and imprisonment for knowing submission of such information, under 18 U.S.C. § 1001.

37. Each party agrees to bear its own costs and attorney's fees in this action.

#### G. General Provisions

38. In accordance with 40 C.F.R. § 22.18(c), completion of the terms of this CAFO resolves only Respondent's liability for federal civil penalties for the violations and facts specifically alleged above.

39. This civil penalty paid pursuant to this CAFO is not deductible for federal tax purposes.

40. Nothing in this CAFO shall relieve Respondent of the duty to comply with all applicable

provisions of the Act and other federal, state, or local laws or statutes, nor shall it restrict EPA's

authority to seek compliance with any applicable laws or regulations, nor shall it be construed to

be a ruling on, or determination of, any issue related to any federal, state, or local permit.

41. This CAFO constitutes the entire agreement between the parties and supersedes any prior

agreements or understandings, whether written or oral, among the parties with respect to the

subject matter hereof.

#### H. Effective Date

42. Respondent and Complainant agree to issuance of the attached Final Order. Upon filing, EPA will transmit a copy of the filed CAFO to the Respondent. This CAFO shall become effective after execution of the Final Order by the Regional Judicial Officer on the date of filing with the Regional Hearing Clerk.
