FINAL DECISION THE CHEMOURS COMPANY FC, LLC BELLE WEST VIRGINIA FACILITY, PLANT AREA

PURPOSE

The West Virginia Department of Environmental Protection (WVDEP) is issuing this Final Decision and Response to Comments (FDRTC or Final Decision) selecting the Final Remedy for environmental remediation at the Chemours Company FC, LLC, Belle Plant Area Facility (WVD005012851) located in Belle, Kanawha County, West Virginia (hereinafter referred to as the Facility). The Final Decision is issued pursuant to the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act (RCRA) of 1976, and the Hazardous and Solid Waste Amendments (HSWA) of 1984, 42 U.S.C. Sections 6901, et seq.

On August 16, 2022, WVDEP issued a Statement of Basis (SB) in which it described the information gathered during environmental investigations at the Facility and proposed a Final Remedy for the Facility. The SB is hereby incorporated into this Final Decision by reference and made a part hereof as Attachment A.

This FDRTC selects the remedy that WVDEP evaluated under the SB. Consistent with the public participation provisions under RCRA, WVDEP solicited public comment on its proposed Final Remedy in the SB as well as the Corrective Action Post Closure Permit (Permit) to be drafted based on the proposed remedy therein. On August 16, 2022, a notice of the SB was published in the Charleston Gazette-Mail, Charleston, WV, and also on the WVDEP website: <https://dep.wv.gov/pio/Pages/Settlements,Ordersouttopublicnotice.aspx>.

No comments were received by WVDEP during the public comment period that ended on September 17 2022. Since WVDEP did not receive any comments on the proposed remedy described in the SB, WVDEP has determined it is not necessary to modify the proposed remedy set forth in the SB; thus, the remedy proposed in the SB is the Final Remedy selected by WVDEP for the Facility.

FINAL DECISION


WVDEP's Final Remedy for the Facility consists of the following:

- Land use restrictions for soils implemented through Institutional Controls (ICs);
- Monitored Natural Attenuation (MNA) of groundwater until drinking water standards are met; and
- Compliance with and maintenance of groundwater use restrictions through ICs

DECLARATION

Based on the Administrative Record compiled for the corrective action at the Chemours Belle Plant Area Facility, I have determined that the remedy selected in this Final Decision and Response to Comments, which incorporates the August 16, 2022 Statement of Basis, is protective of human health and the environment.
