Mr. Hesper:

Thank you for your electronic submittal dated August 29, 2022, transmitting documentation that DJR has completed the screening procedures to address threatened and endangered species (TES) and historic properties for the Largo Canyon West Pad #8 site under the FIP for True Minor Sources in Indian Country in the Oil and Natural Gas Production and Natural Gas Processing Segments of the Oil and Natural Gas Sector. In accordance with 40 CFR 49.104(a)(2), you must obtain written confirmation from the U.S. Environmental Protection Agency that you have satisfactorily addressed these screening procedures. This letter serves as written confirmation that the documentation you have provided has satisfactorily completed the screening procedures to address TES and historic properties for the installation of equipment located on Jicarilla Apache tribal lands in Rio Arriba, New Mexico.

The documentation you provided that includes an Environmental Assessment and a Finding of No Significant Impact supports your determination that no federally-listed threatened or endangered species or their designated critical habitat(s) are likely to occur within the action area of your source and that no historic properties will be affected by the project. With this letter, we also acknowledge receipt of your Part 1 General Facility Information registration form in accordance with the FIP at 40 CFR 104 (a)(2), and we note that Attachment A lists the equipment you plan to construct and operate. Therefore, you may proceed with the installation of the equipment noted in the Part 1 General Facility Information registration form 30 days from the date of this letter.
