What are the California Climate Assessments? California's Climate Change Assessments contribute to the scientific foundation for understanding climate-related vulnerability at the local scale and informing resilience actions, while also directly informing State policies, plans, programs, and guidance, to promote effective and integrated action to safeguard California from climate change

Public Resources Code 71340 (Senate Bill 1320,Stern, 2020) calls on the State, through the Integrated Climate Adaptation and Resiliency Program (ICARP), **to advance action-based** science by developing California Climate Change Assessments at least every five years.













Fifth Assessment Timeline



Climate Data and Scenarios





Competitive Funding Program





Competitive funding program to support a suite of research products that fill gaps in understanding about adapting to climate impacts, in alignment with the State's priority climate research gaps and climate and equity goals.

Core Climate Research

Competitive Funding Program



- Eligibility: All public, private entities, and tribes.
- Research proposal period: Starting early 2023.
- Announcement of awards: Anticipated for mid 2023.
- Final deliverables anticipated Q3 2025.

Competitive Funding Program



Purpose: To support research by California Native American tribes to address tribal needs and questions related to climate change through:


- Research
- Climate Assessments
- Implementation
- Information Sharing
- Tool Development
- Participation in CA Climate Assessment

Eligibility: California Native American tribes, tribalserving non-governmental organizations, and other California tribal organizations

Format: Grants totaling \$3.625 million over three funding rounds and six categories of grants

Near-term Schedule:

- Individual Consultation Meetings Available throughout
- Spring 2023: Round 1 Solicitation & Agreement Development
