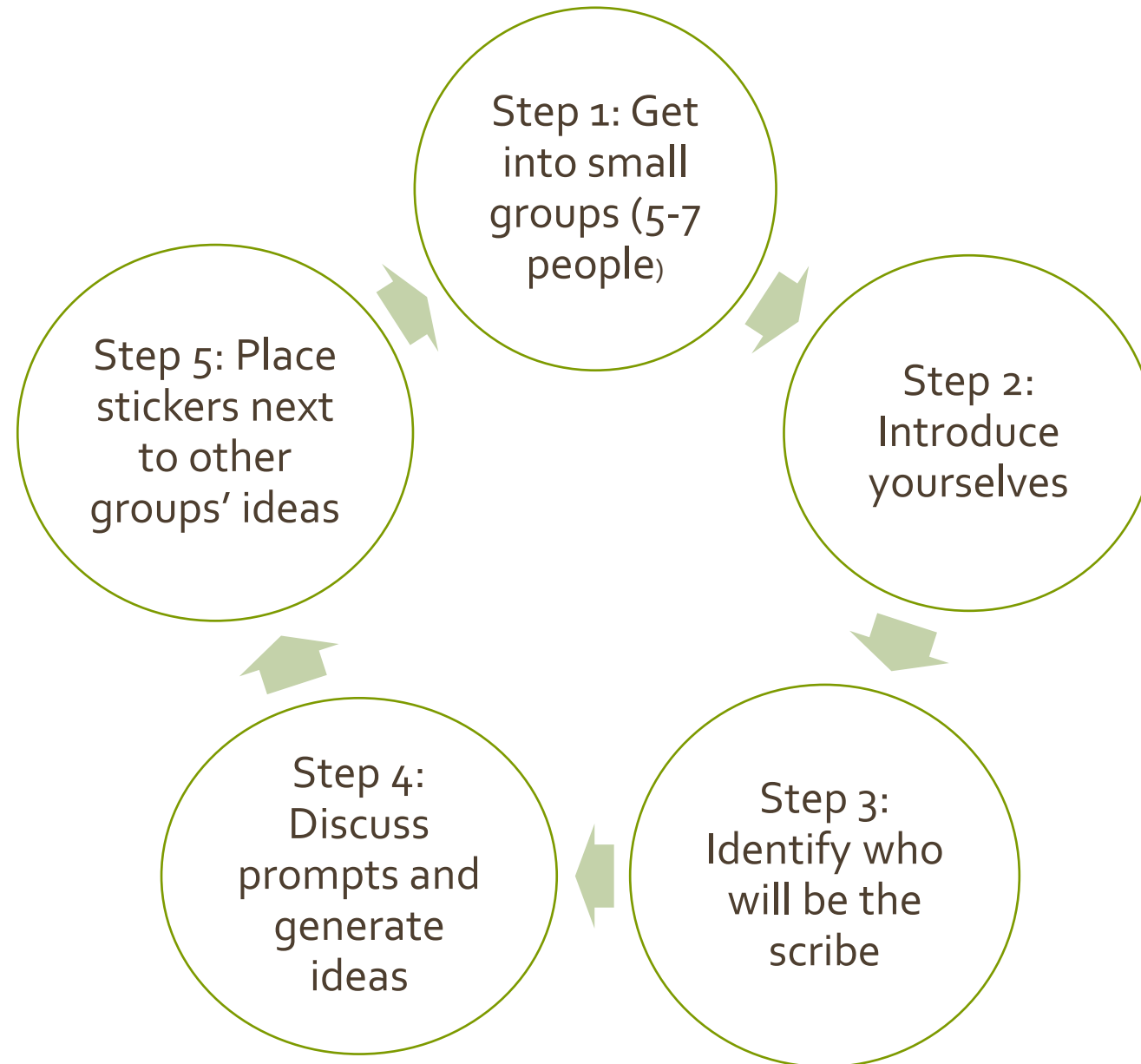
The results are in! What do they reveal?
