Re: Delegation of Section 112 Standards

Dear Genevieve,

Last year IDEM submitted a request for approval of Section 112(l) delegation for certain listed NESHAPs that had been adopted as state rules. At that time you indicated that EPA had not done the best job describing what had been delegated in 1997. In particular the pre-August 1997 MACTs were not listed as being delegated and the delegation mechanism would seem to be limited to non-Part 70 MACTs.

Enclosed are copies of the delegation correspondence, federal approvals (for both part 70 and nonpart 70 sources), and a briefing memo concerning delegated authority; section 112 rules and programs (dated August 31, 2000) that Mike Brooks prepared for Kathy Watson for Indiana's Section 112(1) program. Based on these documents it appears to me that Indiana requested delegation for all federally adopted NESHAPs and has communicated to EPA all those NESHAPs that have been incorporated into state rules. If after reviewing these documents your concern remains, please tell me specifically what needs to be done to assure that the full delegation is affirmed.
