Dear Mr. Czerniak:

This letter is to request delegation of authority to Indiana to implement and enforce the National Emission Standard for Hazardous Pollutants (NESHAP) from Coal and Oil Fired Electric Utility Steam Generating Units, 40 CFR 63, Subpart UUUUU. This request is consistent with United States Environmental Protection Agency's (U.S. EPA) final rule approving Indiana's Section 112(l) Program of Delegation (62 FR 36460, July 8, 1997).

Based on prior program submittals and approvals for Indiana's Title V air permit and Section 112 delegation programs, Indiana has met the "up-front" approval requirements as specified in 40 CFR 63.91(d). The remaining criterion for approval is a demonstration that the State has adequate legal authority to implement and enforce the applicable federal standard. The authority for the Coal and Oil Fired Electric Utility Steam Generating Units NESHAP has been established through state rule, 326 IAC 20-89. A copy of the state rule (LSA #13-488), effective October 19, 2014, is enclosed.

I request that U.S. EPA grant Indiana delegation of approval for 326 IAC 20-89. If you have any questions regarding this request, please contact Susan Bem, Rules Development Branch, Office of Legal Counsel at (317) 233-5697.

Adds <u>326 IAC 20-89</u> concerning the national emission standard for hazardous air pollutants (NESHAP) for coal-fired and oil-fired electric utility steam generating units. Repeals <u>326 IAC 24-4</u> concerning the Clean Air Mercury Rule (CAMR). Effective 30 days after filing with the Publisher.

SECTION 1. 326 IAC 20-89 IS ADDED TO READ AS FOLLOWS:

Rule 89. Coal-Fired and Oil-Fired Electric Utility Steam Generating Units

326 IAC 20-89-1 Applicability; incorporation by reference of federal standards

Sec. 1. (a) This rule applies to sources as provided in 40 CFR 63.9981.

(b) The board incorporates by reference 40 CFR 63, Subpart UUUUU\*, National Emission Standards for Hazardous Air Pollutants: Coal- and Oil-Fired Electric Utility Steam Generating Units.
