1. WQX Project Status Report

a. <u>WQX/WQXWeb performance/updates (Kevin)</u>

Performance for the month of September was overall good, however there was a service disruption on Monday September 25 from 8am - 5pm where the WQX Node was down. We resolved the issue and were back online that evening.

What's NEW with WQX Web 3.0.1 released on 2023-08-25?

- NEW API Rule(s): A minor API service enhancement to reduce server processing of duplicate service calls.
- New WQX Web review report: Monitoring Location Weights
- New Detailed Export to File (Excel): Allows review of All elements for each entity (Projects, Locations, Results, Activities, etc.)
- New matching Import Configurations for Detailed Export Report supporting data RE-submission. This will allow easy resubmission of the full record from the exported report. This is handy for additional reviewers or for situations where you can not easily repeat the original upload procedure to correct errors or make additions.
 - Project #7000, Monitoring Location #7001, Monitoring Location Weight #7002,
 - Metric #7003, Result #7005, Index #7006, Activity Group #7007
- Download all submission documents by transaction_id (No authentication required). This is outside our authenticated space on the WQXWeb application. This means other team members can now easily retrieve the submission documents and QA reports.

Potential Government Shutdown:

What happens to the WQP in the event of shutdown? Development stops but the application remains up and running. We may have one contractor that may be able to continue working and manage the ETL process in the case of new submissions through WQX. Yet to hear if we will add a banner noting status.

Working on a fix for coded values - will be making a fix for that bug.

2. Presentation - Kiki Schneider (EPA-OWOW-WDIB)

Kiki presented on How's My Waterway, the EPA application that shares publicly available water data and information at state and community levels, including data from the Water Quality Portal.

New or interesting features highlighted included:

- Option to export map to Arc Online account
- Ability to Print out map views through a new widget
- Show the upstream watershed of any point
- Add data button curated content, all ArcGIS online
- Added a detailed (state term) use information pop-up
- Surrounding features functions
- Tribal pages
- Monitoring Tab and Waterbody Report
- Data includes:
 - ATTAINS assessments, uses, etc
 - WQP Water sample data

- ECHO Permitted facilities, reports
- USGS gages Real-time USGS gage data
- CYAN satellite data Potential Harmful Algal Blooms
