US Forest Service Urban & Community Forestry Program Notice of Funding Opportunity

The Urban and Community Forestry Inflation Reduction Act Notice of Funding Opportunity (NOFO) has been announced. The U.S. Forest Service is making up to \$1 billion available in Urban and Community Forestry competitive grants for investments that:

- Increase equitable access to urban tree canopy and associated human health, environmental, and economic benefits in disadvantaged communities,
- Broaden community engagement in local urban forest planning,
- Improve community and urban forest resilience to climate change, pests, and storm events through best management and maintenance practices.

Funding Criteria:

- Proposal deadline is June 1, 2023 at 11:59 p.m. ET
- \$100,000 minimum and \$50 million maximum funding request
- 5-year grant agreement
- All federal grant funds are to be matched at least equally (dollar for dollar) with nonfederal match. Match waivers are available for proposals that deliver 100% of the funding/program benefits to disadvantaged communities.
- Organizations must have an active registration and Unique Entity Identifier (UEI) from SAM.gov to apply. Creating a first-time registration may take several weeks or more to complete, so apply for SAM registration early.
