Sec. 1-121. Purpose of article.

The purpose of this article is to provide for the orderly registration of all air contaminant sources, as applicable regulations or emission control standards are adopted.

Sec. 1-122. Application of article.

This article shall apply to all _air contaminant sources both combustion and non-combustion, as set forth in section 1-110, with the exception of Classes V-C and VI-C.

Sec. 1-123. Operator and premises registration.

Within sixty days after the effective date of a regulation or emission control standard, all persons operating sources of such emissions shall register with the Western North Carolina Regional Air Pollution Control Agency, on forms to be made available by the Agency, the name of the person, company, or corporation operating the sources, the address, location, county, and principal officer of the company.

Sec. 1-124. Process registration--Generally.

Within sixty days following receipt of the necessary forms or by a date established by the Western North Carolina Regional Air Pollution Agency, information shall be supplied concerning the process or processes including but not necessarily limited to quantities and kinds of raw material used, process flow sheets, operating schedules, total weights and kinds of air contaminants released, types and quantities of fuels used, stack heights, and such other information as may be considered essential in evaluating the potential of the source for causing air pollution.

Sec. 1-125. Director to establish dates.
