In accordance with Section 22a-430b of the Connecticut General Statutes ("CGS") as amended, the Commissioner of Energy and Environmental Protection ("Commissioner") hereby approves a Registration filed by Hillandale Farms Conn, LLC ("Permittee"), in accordance with Section 4(g) of the General Permit for Concentrated Animal Feeding Operations, issued on January 1, 2023 ("CAFO GP"). This Approval of Registration is based upon Application No. 202309082, received on November 30, 2023, an addendum to the application, received on May 13, 2024, and the administrative record established in the processing of such application.

The Permittee is considered a Large CAFO due to the size of their operation having the qualified number of animals as defined under 40 CFR 122.23.

The wastewater shall be managed in accordance with the terms and conditions of the CAFO GP and the following conditions:

- **Definitions.** The definitions of the terms used in this Approval of Registration to discharge under (A) the CAFO GP shall be the same as the definitions as described in Section 2 of the CAFO GP, Section 22a-423 of the CGS and Section 22a-430-3(a) of the Regulations of Connecticut State Agencies ("RCSA").
- **(B)** Sampling Requirements. All manure and soil samples shall be collected in compliance with Section 5(f) of the CAFO GP and the Comprehensive Nutrient Management Plan.
- Effluent limitations and monitoring requirements. Large CAFOs must comply with the best **(C)** management practices, effluent limitations, and additional measures set forth in 40 CFR 412.
- **(D) Reporting Requirements.** An annual report must be submitted as required by Section 5(d) of the







CAFO GP.







1.2. Farmstead Conservation Practices -- Record of Decisions

This is an existing facility. Layer birds are confined 100% of the time within the barns. Manure from barns 42, 45, 46, 51, 52 and 55 is handled in a high-rise barn system where manure falls from the cages and is stored in the bottom of the barn. The manure remains in the barns until it is loaded onto a tarped truck and exported off the operation. Manure from barns 41, 44, 47 and 54 is handled on a belted manure system that directs manure to roofed manure loading areas at the end of the barns where it is hauled off daily. At times 1 day worth of manure production may be stored.

Mortalities are removed from the barns daily and composted in sealed bins or in buildings 43 and 56. The composting process in monitored by temperature and turned as needed to ensure complete composting.

Egg processing washwater is directed to the Hillandale Franklin Farm waste treatment facility

There are no resource concerns at this facility.

1.3. Farmstead Conservation Practices – Implementation Requirements

This farm operates as an egg laying operation that houses a total of 1,292,250 white egg layers. All birds are confined to the barns 100% of the time. Manure from barns 42, 45, 46, 51, 52 and 55 is handled in a high-rise barn system where manure falls from the cages and is stored in the bottom of the barn. Manure from barns 41, 44, 47, and 54 is handled on a belted manure system that directs manure to roofed manure loading areas at the end of the barns.

Mortalities are collected from the barns on a daily basis and composted in buildings 43 & 56.

All manure and finished mortality compost is exported off site to approximately 134 individual operations located in Connecticut and surrounding states.

Egg processing washwater is directed to the Hillandale Franklin Farm waste treatment facility

There is no cropland or pastureland associated with this operation, therefore there are no manure or fertilizer application associated with this operation.



Hillandale Farms Conn, LLC - Lebanon Topo Map










Hillandale Farms Conn, LLC - Lebanon Soils Map

NOTICE OF TENTATIVE DETERMINATION INTENT TO APPROVE GENERAL PERMIT COVERAGE FOR DISCHARGES INTO THE WATERS OF THE STATE OF CONNECTICUT

1.0 TENTATIVE DETERMINATION

The Commissioner of the Department of Energy and Environmental Protection ("DEEP") hereby gives notice of a tentative determination to approve permit coverage under the Concentrated Animal Feeding Operation ("CAFO") General Permit ("CAFO General Permit") based on an application and administrative record submitted by Hillandale Farms Conn, LLC ("the applicant") authorizing a discharge into the waters of the State under section 22a-430 of the Connecticut General Statutes.

On January 1, 2023, the state of Connecticut issued a CAFO General Permit providing a simplified permitting process for eligible facilities.

In accordance with applicable federal and state law, the Commissioner has made a tentative determination that the registration and Comprehensive Nutrient Management Plan ("CNMP") meet the eligibility criteria of the CAFO General Permit and will protect the surface waters of the State from pollution.

The Commissioner will require that all wastewaters be treated to meet the applicable effluent limitations and permit conditions and periodic monitoring to demonstrate that the discharge will not cause pollution.

No land application occurs on site. Approximately 37,000 tons of manure will be exported from the farm annually.

3.2 Effluent Limits

This CNMP contains site specific nonnumeric technology based best management practices developed to ensure the treatment system as designed and properly operated will comply with the permit terms and conditions and protect surface waters of the state consistent with section 22a-430 of the Regulations of Connecticut State Agencies ("RCSA").
