Dear Northwest Indiana Urban Waters friends.

I am writing to share the news that after 20 years as a Social Scientist with the US Forest Service, I am moving on to a new position. I will soon be a Science Delivery Specialist, working directly with about 100 Forest Service scientists who are spread across a 20-state area. Within the Forest Service it is a relatively small move to a new team, but it means that I have to step away from partnership work, the most engaging and rewarding part of my current job. So, this is a fond and wistful farewell.

I have been with the Northwest Indiana Urban Waters partnership since the very beginning, in some ways since before the very beginning. In May 2011, a handful of people from various federal agencies got together at the Portage Lakefront and Riverwalk and brainstormed a list of state, local, and nonprofit organizations doing waterway-related work in the region. We invited every one of those organizations to the very first partnership meeting at NIRPC in July 2011.

Early on, those of us at federal agencies committed to doing more listening than talking at Urban Waters meetings. We asked the state and local partners to define the footprint of the partnership; after much discussion, the tributaries and sub-watersheds feeding Lake Michigan in Lake, Porter, and LaPorte Counties were selected. We asked people to bring their updates, ideas, and challenges to all meetings and to share them freely.

Urban Waters has always been open to all who want to learn about water-related projects, big and small, going on in the region. Under the continuing leadership of Peg Donnelly (USEPA), Drew Hart (US Forest Service), and Dan Plath (NPS), and the guidance of uber-capable Ambassador Victoria Wittig, the partnership will continue to serve as a convener and catalyst to collaborative work in the coming years.

I will stay on the Urban Waters mailing list and follow news of the partnership from afar. I am proud of all that the Northwest Indiana Urban Waters partnership has accomplished and I wish you all the very best. Please stay in touch if you are inclined to. Bureau of Reclamation WaterSMART Environmental Water Resources Projects

This funding supports projects focused on environmental benefits that have been developed as part of a collaborative process to increase the reliability of water resources. The Bipartisan Infrastructure Law includes additional authority for the Bureau of Reclamation to provide funding for multi-benefit projects that improve watershed health. Indiana American Water Environmental Grant Program

The Environmental Grant Program offers funding for innovative, community-based environmental projects that improve, restore or protect the watersheds, surface water and groundwater supplies in our local communities. To qualify, a proposed project must be: 1. Located within an American Water service area, 2. Be completed between May and November of the grant funding year, 3. 2023 National Brownfields Training Conference

EPA Water Infrastructure Technical Assistance Website

As part of EPA's efforts to implement the Bipartisan Infrastructure Law, the Water Infrastructure Technical Assistance website has been updated. Updates focus on new and existing EPA water and technical assistance programs.

EPA Water Finance Clearinghouse

The Water Finance Clearinghouse is a web-based portal to help communities locate information and resources that will assist in making informed decisions for their drinking water, wastewater and stormwater infrastructure needs.

EPA Webinar on Green Infrastructure and the MS4 Permit: A Compendium of Case Studies

In many states, the MS4 permit acts as a regulatory driver to encourage or require implementation of green infrastructure in MS4 communities.
